The 2017-2018 Membership Report was filed online via CLMS2. As of March 31, the Order ended the year with a total membership of 770,937 for a loss of 4,155 (-0.5%). It is the smallest one-year decline in more than three decades. With more attention to our membership, the Order can show a gain in the next couple of years.

Totals from the Annual Charity Reports show the Order donated an all-time high of \$675,985,245 in time, mileage and

Drug Take Back Day numbers continue to rise

The National Prescription Drug Take Back Day addresses a crucial public safety and public health issue. According to the 2015 National Survey on Drug Use and Health, 6.4 million Americans abused controlled prescription drugs. The study shows that a majority of abused prescription drugs were obtained from family and friends, often from the home medicine cabinet. Unused prescription drugs frequently find their way into the wrong hands. It's dangerous and often tragic. That's why it was great to see thousands of folks from across the country clean out their medicine cabinets and turn in, safely and anonymously, a record amount of prescription drugs.


The Drug Enforcement Agency (DEA) has held fifteen National Take Back days since September 2010. The totals for each are listed to the right. The numbers continue to increase as the message of prescription drug abuse spreads.

Did you miss the last Take Back Day? Prescription drugs can be disposed of at any time. Visit DEA.gov to find a disposal site in your area, or check with your local pharmacist. The next DEA Take Back Day is October 27 from 10 a.m. to 2 p.m.

A brief tribute to the majestic elk

An Elk has a reputation for toughness, endurance, loyalty, and... a four-chambered stomach.

This of course refers to elk, the largest subspecies of red deer in North America, and not necessarily the Members of this benevolent order.

While some people who live out west could easily distinguish a Manitoban elk from a Rocky Mountain elk, many other Members may have never seen one.

The Order's namesake is a fascinating creature. Here's what you may not know about elk.

- Elk are endurance runners. They form large groups, known as "gangs," to protect against predators, which include coyotes and bears. Cows (female elk), calves and yearlings live in loose herds, while bulls (male elk) form their own groups or live alone.
- An Elk's antlers can grow an inch a day and become four feet long and 40 lbs. that escaltaes to a heavy. Elk lose their antlers in March but

grow them back in May in advance of the fall breeding season.

- Some cultures regard the elk's antler velvet as an aphrodisiac.
- The North American elk has four living and two extinct subspecies. Other members of the elk family can also be found in Eastern Asia, Argentina, and New Zealand.
- Elk have four-chambered stomachs and can eat 20 lbs. of vegetation a day.
- Elk vary in size, from the Roosevelt elk that can weigh upwards of 1,100 lbs., to the Tule elk, which only can get to around 550 lbs.
- Much like humans, bulls compete and fight with each other for cows. Unlike humans, male elk are known to roll their bodies in their own urine to attract mates.
- Elk attack by charging with their antlers and punching with their front hooves.
- The elk's primary intimidation strategy is bugling, a high-pitch bellow that escaltaes to a squealing whistle and ends with a grunt.

Do you know your state alcohol management laws?

Laws regarding business operations, legal gambling, and alcohol sales vary by state. Knowing the laws and regulations in your city and state are important to your operation.

Because of continuing problems regarding alcohol sales and service, Lodges need to know about responsible alcohol management and the law regarding not serving Visibly Intoxicated Persons, also known by bartenders and servers as

Every Lodge should have a written policy instructing servers and managers how to handle most situations that may come up regarding the serving of alcohol. Rules regarding Visibly Intoxicated Persons could help reduce your risk of liability.

First and foremost, servers and

the law to serve people who are visibly they are having a bad day. If so, a server intoxicated. If a Visibly Intoxicated Person gets into or causes an accident, the server and the Lodge could be held accountable.

Recognizing a person who is visibly intoxicated is not difficult when servers and managers know what to look for. Some signs to notice if someone is intoxicated:

- Acting loud and boastful
- Drinking alone and fast
- Ordering doubles
- Buying round after round for friends
- Crude behavior
- Slurred speech
- Stumbling and bumping into things
- Falling asleep at the bar

These are some of the signs of visible intoxication. As soon as any of these are noticed the service of alcohol should be stopped immediately.

By knowing your customers and talking managers need to know that it is against with them you may be able to find out that

might try to slow down their drinking by putting a glass of water in front of them between rounds, getting busy with some task to slow down service, or inviting them to have something to eat.

You should make your policy part of new and continuing employee training. Also, your policy should include filling out Incident Reports for fighting, intoxication, falls, anything your employee did to get the intoxicated person home safely (accepted or not), and anything else that could cause your Lodge a problem in the future. All reports should have a date, time, witnesses, and signature. They should be kept on file for two years.

We are all paying more for insurance coverage because of various problems caused by irresponsible alcohol service. This is a problem we can control through education and responsible alcohol management programs.

MVS Scholarship opens this month

Every year, the Elks National Foundation awards the Most Valuble Student scholarship to 500 of the most intelligent, service-minded leaders who are embarking on their college career.

The application opens online on August 15. All high school seniors who are U.S. citizens are welcome to apply. Applicants will be judged on scholarship, leadership, and financial need. The top 20 finalists will participate in an all-expenses paid Leadership Weekend in Chicago April 11–14, 2019.

Throughout the weekend, the finalists will engage, serve, and interview with national judges for the top prizes. Two first-place awards of \$50,000, two second-place awards of \$40,000, and two third-place awards of \$30,000 will be given to the top scholars. The remaining 14 finalists will receive \$20,000. The 480 runners-up will receive fifth-place scholarships of \$4,000.

Freedom Grants may be going fast, but don't forget about all the other Lodge grants available! If your Lodge would like to use a grant to serve veterans and military members in need this year, here are a few ideas to get you started.

Consider getting involved with a local Stand Down for veterans. A Stand Down event provides a central location provide. To offer continued supto distribute supplies and services to port, include invitations to meals or veterans experiencing homelessness. Veterans come to Stand Downs to receive veterans in need. food, shelter, clothing, health screenings, haircuts, and dental exams. At some veterans and transitioning service events, providers also offer referrals to members with their employment search

housing, employment, and counseling.

To get started, contact your nearest VA and other community veteran organizations to find out if a Stand Down is planned in your area. If an event is not already planned, look for a location where your Lodge can establish one. Determine what supplies or services your Lodge could other events that your Lodge will give to

Your Lodge could focus on assisting additional assistance such as health care, by holding a job fair. Find partner

organizations and service providers that can offer a variety of resources that relate to veterans who are seeking

employment. Search for companies that have made a commitment to hiring veterans. In addition to offering information about job openings, make the most of the event by providing concrete resources such as clothing appropriate for employment, assistance with transportation, and job interview practice sessions.

Don't forget about supporting military families. Many families could use a hand collecting supplies for new babies or kids

75,000 new Elks push membership rates to 38-year high

The BPOE has made its strongest progress in membership since 1980. We were down just 4,155 Members, or 0.5 percent. We added 75,709 new Members and reinstatements.

This marks four consecutive years of improvement. We again set a new national record for the fewest membership cancellations.

7,072 fewer delinquents than the previous year, and 26,028 fewer delinquents than Prom/Graduation for three high schools three years ago.

Initiatives such as the All-American Lodge — Contest "A" are great for driving Membership and promoting Elkdom. Osage Community, MO Lodge No. 2705, the second-place winner in Division IV, held fundraisers to provide groceries and toiletries for 100 families and toys for 378

We began this new fraternal year with children at Christmas. The Lodge also used a Gratitude Grant to fund Project and an Anniversary Grant to send two teens to flight camp. Osage Community welcomed 100 new Members over the past year for a net gain of 33 new Members.

> We've made a three-year improvement of \$2.6 million while reducing delinquency in our Lodges. Thank you for all you have done to help make that happen.
