QR CODE PROGRAM

What does this mean? QR CODE = QUICK RESPONSE.

Our State Public Relations Team is introducing a New Program as we move forward. This new program is the QR Code, which will allow for easy and quick access to our Web Site or a particular page or document file on our website.

It is commonly used on Mobile Devices – i.e., cell phones or tablets. Your device may be in camera mode, or you may download a free QR Reader (scanner) app for quick scanning. (Some laptops and desktops with a camera may also be able to read the code.)

If you choose camera mode:

Open your camera, and focus the code in your viewfinder.

A link will automatically appear on your screen.

Tap this link, and it will take you to the Website or Document for which it is built.

If you use a QI Code App:

Open your app.

Point your phone screen on the QR Code (you may see a red line going up and down, reading the code for a brief moment.)

You will automatically be taken to the corresponding website.

The QR Code is usually black squares or maybe in color. You will see these codes appear on a TV screen, computer screens, or print in magazines and newsletters. It is an easy navigation tool for mobile users.

ACCIDENT PREVENTION REPORT WINTER OF 2020

"Lodge Safety Reports are Serious Business"

As we close out the old Elk year and start a new one, I would like to take a second to

thank President Burgoon for allowing me to serve as your State Accident Prevention Chair, and State President Elect Raleigh for keeping me on. My job in construction and my certification of OSHA 30 gives me an advantage in the world of safety. Every Lodge should take the Lodge Safety Reports seriously! The width of that piece of paper is the only thing between your Lodge and a lawsuit. Please do not skip any of the boxes during your inspection. Test, evaluate,

and remedy all items on the checklist. Situations change, new equipment is introduced into the Lodge, and wear and tear can all contribute to an accident. Safety is not just your Lodge Safety Chairperson's responsibility, it's the job of every Elk member. If you see a safety concern, let the House Committee know and they will address the issue. It should be corrected in a timely manner and posted inside the Lodge. I wish your Lodge a safe and prosperous Elk year, and I will see you in Cape Henlopen. Here's the latest and greatest Grand Lodge Safety tips for you to inspect.

LODGE RENTAL AGREEMENTS

The following should be included in all rental agreements:

- Follow pages 10-11 of the Liability Insurance Program
- Require a certificate of insurance naming the Lodge as additional insured;
- Include a provision for an indemnity agreement;
- Describe the area to be rented, indicate any restrictions on use;
- Indicate any limitations regarding capacity;
- State all rental fees and a clearly defined cancellation policy;
- Verify with the proper authority that the Lodge's liquor license allows service of alcohol to non-Members;
- Service of alcohol must be controlled by the Lodge, no

- outside alcohol is allowed;
- Self-service of alcohol and self-service kegs are not allowed;
- The Lodge will reserve the right to refuse service to anyone at the discretion of the servers;
- The renter's clean-up responsibilities/requirements should be clearly indicated;
- The Lodge must not sign an agreement assuming responsibility for hired security personnel;
- The Lodge has the right to stop inappropriate behavior;
- The Lodge has the right to shut down the event; and
- Consider having an attorney review the rental agreement.

IT IS THE START OF A NEW LODGE YEAR

Now is a great time to examine the Lodge's legal wellbeing:

- Where are the Lodge's legal documents located?
- Are state and local filings and registrations maintained?
- Become familiar with all Lodge contracts.
- The officers and trustees should know all Lodge obligations.
- Lodge officers and trustees must maintain proper records.
- Contracts should avoid a conflict of interest.
- Does the Lodge have written personnel policies?
- The Lodge should have written work rules for its employees.
- Does the Lodge have an attorney that can review contracts?
- Now is the time to diary important dates such as renewal of licenses

- and permits.
- Does the Lodge have service contracts with repairmen, plumbers, electricians, etc.?
- If so, such service contracts should provide the Lodge with indemnification.
- Indemnification includes the obligation to protect the Lodge from claims made by the contractor's employees.
- Service contracts should require that all contractors provide evidence of liability insurance.
- Service contracts should include contractual liability coverage.
- The Lodge should be named as additional insured on the contractor's insurance policy.
- It is unacceptable for the Lodge to indemnify other individuals or corporations.


- Are the Lodge's financial and business records properly filed for retrieval and provided with back-up redundancy?
- Has the Lodge prepared a rental agreement or contract to be signed by individuals or entities using the Lodge, according to the Laws of the Order?
- In these agreements, the entity using the Lodge should hold the Lodge harmless for activities and provide evidence of insurance coverage (see Pages 10-11 of the Liability Insurance Program booklet).
- Now is the time to review the Accident Prevention Manual and Liability Insurance Program booklet, which are posted on the Safety & Insurance page of the Elks website.



According to E.R. C.L Marshall, "This is a wonderful example of how our local Elks Lodge can make an impact on the local community. We are pleased to partner with the Worcester County Health Department to provide this space for educators and others desiring to have the vaccine to do so."

"We're showing the community the National Guard and the Pocomoke Elks are here to support them," said Jarvis Fosque of the Maryland National Guard's 1229th Transportation Company.

Throughout the pandemic, Fosque's company has assisted in various ways, delivering critical items such as food, PPE, and medical equipment where needed. Fosque said he was happy to help out with a vaccine clinic. "This is hope," he said. "We're fighting to get everything back to how it used to be."

Worcester County Commissioner Chip Bertino praised the National Guard, the health department, and the Elks Lodge for the smooth operation of Friday's clinic. He said that as of Friday, Worcester County topped the state in terms of the percentage of its population who had received the first dose of the vaccine.
