The principle is never touched. We re-invest in the youth of our communities.

Since our meeting in October, another \$5900 has been distributed to Camp Barrett and a child sponsored by the Selbyville Lodge. Exalted Rulers, there is over \$21,000 still available for distribution this year. There must be a family in your local communities who needs our help. 

#### **Government Relations Reminder**

The First Amendment to the Constitution of the United States establishes our right to exist as a private organization.

The Supreme Court reinforced this right by stating.......
"the First Amendment and related guarantees of the Bill of Rights...... create a zone of privacy which precludes government from interfering with private clubs or groups."

One of the objectives of the Government Relations program is to help us protect this right to exist as a private organization. It is the duty of lodge officers and members to ensure that Elks policies provided in the Statutes as all as public regulations at all levels of government are followed diligently. We cannot afford any lapse that could affect our private status.

In addition to the probable fines and/or changes in the lodge's tax status that could occur, the word from Grand Lodge is that any lodge which may be deemed a "public accommodation" will surely lose its Charter.

We talk over and over again about "public accommodation," but I am sure that the seriousness of this subject is often placed on the back burner as each lodge puts expediency ahead of proper procedures. Private organizations generally and increasingly encountering greater scrutiny from the IRS, state legislatures and local governments. It is important that lodges heed the concerns of their Government Relations chairpersons in guarding against these challenges. The first line of defense is the lodge itself.

So often, you have heard about maintaining a "closed door' policy, wherein all visitors to the lodge must be signed in. Encourage members to explain to their guests that they must sign in to protect our organization. It is not an inconvenience; it is necessary to ensure our right of privacy under the Constitution -just like the other rights embodied in the Constitution.

In addition to the "closed door," lodges must make sure that their business practices do not allow any leeway for being considered a "public accommodation." In this regard, lodges must follow the golden rule: 'thou shall not sell to anyone not an Elk." This rule pertains to lodges providing food and drink to outside parties - including bingo. The line is very thin here between strict adherence to proper procedures and practical operations. Lodges must also abide strictly to local gaming regulations and reporting guidelines. I stress "local" here because there have been several attempts by the Maryland legislature to centralize gaming at the state level instead of at the county level. Maryland lodges should talk to their local Delegates or State Senator about our concerns in this matter. In all of these issues. I am sure that the rules are broken one way or another daily. You must, however, be aware of the consequences as our private status is increasingly threatened by the courts, legislatures and municipalities. Be aware.

#### **ELKS AND SCOUTING**

Many Lodges in the MD, DE, and D.C. Elks Association sponsor a Boy Scout Troop, a Girl Scout Troop or both. If your Lodge does not do so, consider contacting the appropriate Scout Executive in your area.

Many Lodges also have an Eagle Scout and Girl Scout Gold and Silver Award Recognition Program. The newest Eagle Scouts and the latest Gold and Silver Award recipients are often invited with their parents to attend a Youth Awards Dinner at the Lodge. The young men and women are presented with an American Flag and a certificate from the Lodge.
