Message from the State President: Challenges Launched

Welcome to Prince Frederick in beautiful Calvert County, a long drive for many of us but what else are you going to do on a January weekend after New Year's and before the Super Bowl. It really is too cold to play golf.

Last October I asked all of you to undertake four missions: (1) membership, (2) ENF, (3) Scouting, and (4) Good Kids. And I warned you that I would expect reports on these missions. I also offered small rewards and promised a full de-

briefing at this winter workshop. That debriefing starts with ENF.

In visiting 22 lodges officially from last September to December, I have championed ENF to the new—and the more experienced—members (I say more experienced because "old" is not a word I like to contemplate). Every new member initiated during an official visit was challenged to fork over \$10.00 to ENF before leaving the lodge room. They did. If there was no Initiation at my official visit, I challenged the officers who may have neglected ENF to follow my example and contribute. Most did.

The point is that ENF is a lifetime investment for every member of our Order. I've always believed that, and our state chair, Claudia Finley-Bryant from Waldorf Lodge No. 2421, will justify that belief at one of our breakout sessions this weekend. Claudia will explain when and why ENF got started, how the operation works, who actually runs the fund, what programs are included, and where the money goes. She will also report on how many of you accepted that mission last October to persuade a fellow member to part with \$10.00 for ENF. If you all did, then maybe every lodge has met our Grand Exalted Ruler's goal of \$4.50 per member.

Your membership mission was to get a newly initiated member involved in the workings of your lodge—I left the specifics up to you. Our membership chair, Chuck Donaldson from Prince George's County Lodge No. 1778, assisted by the district chairs, will moderate a brainstorming session on the Order's biggest challenge, retention of the members we have. The goal of this session is to provide innovative ideas to solidify the bonds of membership first fashioned at Initiation. What turns off those new members, initially so full of enthusiasm, so that after

a year or two, they end up on the lapsation list? Our Order needs answers, and you can help find them.

The other two missions are underway. Our Scouting Coordinator, Joe McGeeney, is working with the lodges to ensure that every one is sponsoring or chartering at least one Scouting unit. Joe's challenge—and yours—is 100 percent of the lodges supporting this source of future members. And our Youth Activities Chairman, John Istvan, will kick off the Good Kid medallion program this weekend.

In addition to our missions, two other breakout sessions will take place on Saturday morning. The first concerns Government Relations, chaired by David Wolcott of Easton Lodge No. 1622. To some of you, the word "government" might be off-putting, but the term covers a plethora of issues that can impact our lodges like a falling meteorite. They range from discrimination policy to Internal Revenue Service audits, to ASCAP demanding royalties, to the postal service regulations, closed-door mandate, unrelated business income, and maintenance of charitable status. Someone once said, you don't know what you don't know. But as private entities dealing with the government's many intrusions into our lives, all lodges and their leaders need to know all that we can know.

The final breakout session will focus on the five-year plan. In governmentese, I'm talking about a strategic plan—a methodical system of setting lodge goals, assigning responsibilities, implementing actions, charting progress, and modifying the results as needed. Such a plan involves all aspects of your lodge, revenues, expenses, charity, membership, location, and physical plant. Where will your lodge be in five years? Where do you want to be? Lodges that are not thinking about answers to those questions are inviting future extinction, because an organization that does not grow will eventually die. And we have certainly seen the demise of lodges in our association.

On a personal note, I have truly enjoyed my official visits—and a few non-official, social visits—to the lodges in our association. My next goal is to visit the other 16 lodges unofficially and to do that I need your help. I'd like to attend meetings at which new members will be initiated—under the Good of the Order, I have a few thoughts to share. So please let me know over the next few months when your lodge schedules a group Initiation and e-mail me an invitation. I will try to be there.

VP WEST DISTRICT REPORT

ELKS NATIONAL VETERANS SERVICE COMMISSION OUR HOMELESS VETERANS

America's homeless Veterans have served in World War II, Korean War, Cold War, Vietnam War, Grenada, Panama, Lebanon, Operation Enduring Freedom (Afghanistan), Operation Iraqi Freedom, or the military's anti-drug cultivation efforts in South America. Forty-seven percent of homeless Veterans served during the Vietnam Era. More than 67% served our country for at least three years and 33% were stationed in a war zone.

Although accurate numbers are impossible to come by ~ no one keeps national records on homeless Veterans — the VA estimates that nearly 200,000 Veterans are homeless on any given night and nearly 400,000 experience homelessness over the course of a year. Conservatively, one out of every three homeless who are sleeping in a doorway, alley or a box in our cities and rural communities, has put on a uniform and served this country and account for 23% of all homeless people in America.

With an estimated 400,000 Veterans homeless at some time during the year, the VA reaches only 25% of those in need, leaving 300,000 Veterans who must seek assistance from local government agencies and service organizations in their communities.

Each year, 2.3 million to 3.5 million people have experienced homelessness in America. By taking 23% of that range for Veterans, that would indicate there are between 529,000 and 840,000 Veterans who are homeless at some time during the year.

What services do Veterans need?

Veterans need a coordinated effort that provides secure housing and nutritional meals; essential physical health care, substance abuse aftercare, mental health counseling; personal development and empowerment, job assessment, training and placement assistance.

What seems to work best?

The most effective programs for homeless and at-risk Veterans are community-based, nonprofit groups of Veterans helping Veterans. Because government money for homeless Veterans is currently limited and serves only one in 10 of those in need, it is critical that "WE, THE ELKS" reach out to help provide additional support, resources and opportunities.

What can you do?

- Determine the need in your community. Visit with homeless Veteran providers. Contact your local mayor's office for a list of providers.
- **Involve others.** If you are not already part of an organization, pull together a few people who might be interested in attacking this issue.
- Participate in local homeless coalitions. Chances are there is one in your community. If not, this may be the time to start bringing people together around this critical need. **Send a financial donation** to your local homeless Veteran provider.
- Contact your elected officials, and discuss what is being done in your community for Homeless Veterans.

Remember our Pledge, "So long as there are Veterans, the Benevolent and Protective Order of Elks will never forget them". This is an integral part of it.

Assistance for worthy, needy Member

Needy Elks Members can qualify for up to \$1,000 in an emergency 50-50 matching grant from the Order under Section 5.070 of the Grand Lodge Statutes.

The assistance would be available to "worthy and needy Members of the Order who are suffering from diseases of an incurable character or from total disability, and who are without funds or property or relatives able or willing to care for them," the statute states.

The statute also provides that the Lodge of the assisted Member "shall contribute toward the relief of the Member an amount not less than one-half of the sum that is contributed by the Order."

The assistance program is administered by the Board of Grand Trustees, which is authorized to appropriate up to \$10,000 annually for the program. The board by resolutions may give the Grand Exalted Ruler up to \$1,000 so that authorized payments may be made regularly to hime.

"The monies so approprated shall be adminstered by the Grand Exalted Ruler with the consent of a majority of the Board of Grand Trustees," the statute states. Reprinted From January Issue GL Newsletter
