Message from the State President

February is now history, with another Elks birthday and another lodge election cycle behind us. Having survived the latter one way or the other, members must now be thinking about the lodge year ahead. Thinking is good, of course, but planning is better, and doing is best of all.

That is why this spring workshop will focus on planning and doing. First, our state ritual chairman, Dick Fleck, will conduct a demonstration of

parts of our Order's ritual—the opening, the closing, balloting on candidates, death of a member, and honors to guests. The current Exalted Rulers will take the chairs and act as guests—after appropriate rehearsal and coaching. The objective of this exercise is to provide the new officers with a consistent template for conducting these basic rituals in the lodge. And each incoming Exalted Ruler gets to take home a three-ring binder detailing how to do it all—the right way.

After that, we will break up into two focus groups. The newly elected officers, including repeats and those moving up, will meet with several past state presidents led by PSPs Frank Clopper and Vince Pingitore for a round-table discussion on "What Every Officer Needs to Know." Topics include: leadership skills, committee liaison, financial matters, and statutory responsibilities. Even those who think they know it all may learn something new.

The other group will focus on the Lodge's Governing Body, familiarly known as the House Committee, the workhorse of any lodge. Past state presidents will introduce guidelines and templates for House Committee operations, including (1) integration with Lodge events; (2) tracking income, costs, overhead, and inventory; (3) full disclosure reporting to the lodge; and (4) sub-committee assignments and member responsibilities. All members who have served, are serving, or will serve on House Committees are invited to attend this session.

The highlight of our workshop will be the Homecoming of our Grand Exalted Ruler, Paul D. Helsel, and his wife Jane. Naturally, special events are planned. On Friday, we'll have a Jail Night fund-raiser for the Wounded

Warriors program, featuring our own Judge, the Hon. Carlon O'Malley, "High Noon" Sheriff Mike Green, and assorted "felons" wanted for various heinous offenses, whose followers will have to buy their way out of, or pay to keep them in, the jail. On Saturday, the Terrific Trio of Nancy Wert, Martha Scully, and Kelley Randolph will conduct a silent auction to benefit Elks Camp Barrett. Each lodge has been asked to contribute an auction item, and Amazing Auctioneer Bill Wert will choose a few for a live-and lively-auction. As in Anaheim, we will have some fun.

On another subject, whether or not you are having a personal recession in the present economy, you need to think carefully about the proposed dues increase on which we members will vote this weekend. The proposal is to increase the association's per capita fee from \$2.25 to \$4.25. Arguments will be heard on both sides of the issue, but the available statistics show that in addition to a per capita fee, 12 state associations also assess a special fee. The total amounts range from a high of \$13.00 per member in Alaska with 17 lodges and 7,000 members to a low of \$1.00 per member in New Jersey with 118 lodges and 42,000 members. Most state association fees per member are in the \$3.00 to \$5.00 range. Consider the arguments carefully and vote wisely.

In closing, I'd like to borrow a bit of wisdom from one of our past state presidents (that would be Bill Buttrill). If any of you were asked, "Are you proud to be an Elk," I'm sure your answer would be yes. But just how proud are you? At lodge functions and state association events, some members' jackets are literally encrusted with dozens of Elks pins and other memorabilia. But what about at non-Elk events? Are you willing to proclaim your Elks allegiance at work, at church, at social functions like weddings and parties, on vacation?

Luckily, our Grand Exalted Ruler has provided the ideal pin-it's got a flashy little diamond and the word Elks, and it doesn't weigh a lot. Why not get into the habit of affixing Paul's pin to your collar or lapel every day? What are the chances that someone might ask you about that pin and thus give you the opportunity to tell them all about the wonders of Elkdom? And what might that lead to? At the very least a chance to publicize Elkdom and maybe even a new member! So why not "Be Proud to Be an Elk" and pin your pride on your person.



Government Relations Report

The Maryland legislature is in full swing as this is written and the issue of gaming, namely the ability of eligible (fraternal, non-profit) organizations to own or operate slot machines statewide. Senate Bill 49, sponsored by Sen. Klausmeier and Senate Bill 102, sponsored by Sen. Stone were heard before the Senate Budget and Taxation Committee on Feb. 4th. The companion House Bill 608, sponsored by Del. Weir, will be heard before the House Ways and Means Committee on Feb. 25th. These bills mirror the legislation that was enacted in 1987 enabling organizations on the Eastern Shore to have up to five (5) slot machines. This legislation, if passed, could greatly enhance a lodge's charitable efforts as 50% of the proceeds are mandated to be given to qualified charities, while the lodge may keep the other 50%. All of the Senators and Delegates have been contacted encouraging their support of this legislation and they have been provided with a copy of our National Charitable Records Survey to reinforce our request of their assistance in helping us increase our charitable works. Information has been sent to all of the lodges encouraging them to contact their Senator and/or Delegate, to inform them of all of their contributions to their community and asking for their support in passing these bills.

I mentioned our Charitable Records Survey; as we approach the end of our lodge year it is extremely important that the lodge Secretary's complete the Annual Report. This can now be done electronically through Grand Lodge, but I will need copies of Page 2 also and they can be sent either by e- or snail mail, preferably by the first week in April. These reports contain the information that is most valuable when we approach our State, Federal and Local representatives for help with positive or negative legislation that either affects our charitable and communityoriented efforts or attacks our private and charitable status. It is most helpful, and impressive, when we can show our legislators in black and white the hundreds of millions of dollars our Order contributes not only in cash, but also in volunteer hours to support Youth, Veteran and Community Service programs. These reports are vital in compiling accurate information; you've done the work, take credit for it.

Each lodge should receive the monthly Grand Lodge newsletter. The February issue, besides having Paul's smiling picture on the front, also included an excellent article by the Hon. Roland A. Seal, Vice-Chairman of the Government Relations Committee,

entitled "Can a Lodge Afford UBI?" (Unrelated Business Income). I respectfully urge each of us to review what Roland has to say and take it to heart. This topic was discussed in some detail in Calvert and this article reinforces the immediate need for our lodge's to examine their revenue policy derived from public accommodation. Please remember Section 14.130 of the Statutes, better known as Rule#1 - Thou Shall Not Sell to A Non-Elk! We are all struggling to stretch our lodge budgets these days while continuing our charitable donations and good deeds, but it is not worth the risks to derive our income by opening our doors to the public and competing with facilities that don't enjoy our tax-exempt status. We are a private and fraternal organization and our Home and Club is limited to members, their spouses, and guests - not a public accommodation. The best resolve we can make is to KIP - Keep It Private.
