

Anyone who has been hospitalized for a length of time will understand the loneliness and depression experienced by veterans who either live in a facility or are confined to their homes. Visits from family and friends may be infrequent or non-existent. Elks Veterans Volunteers make special efforts to visit, call, send cards, and bring them to special events. This personal contact we call adopting, for these are the actions of a family reaching out to loved ones.

Stewart G. Israel of Plymouth, Michigan Lodge No. 1780 is Chairman of the Adopt-a-Veteran Program. Brother Israel, as a dedicated VAVS representative, also takes an active part in adopting veterans in hospitals and working closely with the homeless.

It is estimated that almost 200,000 veterans are part of our Adopt-a-Veteran program nationwide. Adopting

a veteran is our way of saying 'Thank you for your service to this country, and we will always remember you'. We are grateful for the commitment of Brother Israel and the volunteers at the Lodge, District and State level who so willingly adopted these men and women.

did an excellent performance of the memorial service. After the service we stopped at Dover Lodge for an enjoyable dinner.



Those who complete the exercise with not more than 5 incorrect answers will receive a Grand Exalted Ruler cita-If you want your answer sheet returned to you, please enclose a selfaddressed stamped envelope.

Thus far, there have been 5 lodges that have participated in the Elks Training Course, these lodges all from the West District, which give the West 100%, with 20 participants.

I encourage all District Deputy Grand Exalted Rulers to include a breakout session at one of your clinics to give each lodge in our association an opportunity to participate in Elks Training. I want to thank you in advance for your assistance in helping our State Association toward our goal of 100% participation.

Congratulations to each District Chair for your appointment this year, and I encourage you to work in conjunction with your District Deputy to attain 100% in your respective districts. If you have NOT received a copy of the test, please notify me and I will forward one to you.

It is my goal this year to once again reach 100% participation, but also with a higher number of participants than before. Last year, 282 members took the test, but I would like to reach over 300 this year, and I know that our members can achieve this small feat.

Remember, the deadline is March 15, 2011.

AUDITING & BUSINESS PRACTICES:

This is a reminder that your State Auditing & Business Practices Committee has been working hard this past year to assist lodges. Remember, our assistance is confidential and no report goes to Grand Lodge. If your lodge is making a profit (at least 24% or more) and, making budget with no problems making money, that's GREAT! But, if you're not making a profit of at least 24%, plus making budget, then you may need to look at your overall lodge finances. Do you know how I arrived with a 24% profit figure?

Here are some questions that may help:

- Do you have computerized accounting?
 - a) Are you using these reports to manage your lodge?
- Are monthly written reports given with two (2) weeks of event?
 - a) Are you making a profit?
- How much cash do you have in reserve?
- How long will this reserve last?
 - a) One Month?
 - b) Two Months?
 - c) Three Months?
 - d) None of the above?
- 5) Do you have a plan for your year?
 - a Is it a one year, two year or longer plan?
 - b) Who helped with this plan?
 - c) Just flow with the same thing?
- 6) What's the plan?
 - a) Does it include all ages?
 - b) Does it include improvements?
 - c) Does it include inflation factor?
- 7) How much does it cost you to run your lodge?
 - a) By the Month?
 - b) By the Week?
 - c) By the Day?
 - d) By the Hour?
- 8) Do you have proper "financial" checks and balances?
 - a) Is your audit team active?
- 9) Do you get written monthly financial statements?

Many times members do not receive their notices of renewal because their contact information has changed and they did not contact the Lodge with those changes. In some cases, members have paid their dues but because their contact information was wrong, they do not receive their new membership card. If the above has happened to you, not receiving your dues notice or your new card, contact the Lodge Secretary. They are there to assist you. Just don't let it go. If there is any doubt when your membership expires, look at your card, it will tell you.

Remember, once you become an inactive member, you forfeit all your rights and privileges that were afforded to you as a member of the BPOE when you first joined.

SO....maintain your good standing in the BPOE by keeping your dues current.

Accident Prevention Report

It is with much regret that I have received this committee due to the passing of Jack Conrad, Dover, who was chairman of this committee for the past few years. He will be missed by all.

I am looking forward to receiving the Self Inspection Reports from the District Deputies when they do their lodge visits. I will forward onto Bill Kummer, co-chairman, who will review the reports in the North East and South East Districts.

We will then contact the lodges within our Association to confirm that any discrepancies on these reports

are, or have been addressed by the Accident Prevention Chair in the lodge.

All lodges should review the security arrangements and avoid large amounts of cash kept overnight in the lodges. In the past we have had similar situations where it seemed to indicate that criminals have targeted Elks lodges and similar organizations. Lodges should consider, 1. Keep cash on hand in small amounts, 2. If possible, obtain burglar alarm stations if economically possible, 3. Interior

and exterior video surveilliance, 4. Burglar resistant doors, locks and management with control of all keys.

In the last few months, there has been an unusually large number of claims. Entries on steps and rising levels in the lodge. Special attempts should be made to make sure that there are no tripping hazards or obstructions.

Do not allow persons to use stages, except when absolutely necessary. When in use, there should be railing to eliminate chances of falling.

Remember, the biggest part of any Accident Prevention activity is communication. Not only the communication from your State Chairman to the lodges, but also within the lodges is vital between leaders and members.

In November I will be attending a seminar in Chicago on Accident Prevention, and I am looking forward to being your State Chairman for 2010-2011.
