

But if a member does anything outside the Lodge that is charitable, the Secretary would not know so it would be up to YOU as the member to have it recorded. Here is one example: Your next door neighbor is elderly and cannot clean the snow off We as Elks have to continue in our efforts to do all we can for the sidewalk. You do it out of concern for that nice neighbor. That counts as community service or helping a Veteran. You may do more of these wonderful things for people that you do not know are countable for the ELKS charitable reporting. Here is another example: You give away things to the Goodwill Stores, Thrift Shops, Church or yard sale the Lodge holds. These are things that according to the IRS are worth a noncash donation, how many times have you done that? The Lodge Secretary would not know about these donations so you could record that information in the charitable workbook on the Secretary's desk and they could post it from the workbook. Yes, all these things count and many more like these examples. Why? Because as an ELK, you are charitable to all mankind.

HELPFUL LODGE TIPS

Helpful tips, Bingo:

Lodge can reduce the likelihood of a claim arising from Bingo operations through proper planning:

CONTROL TRAFFIC: Make sure your parking lot entrances and exits are clearly marked and well lit.

MAKE SURE THERE ARE NO PATHWAY OBSTRUC-TIONS: Make sure the Lodge has proper signage for mem- serviced? bers and Lodge rentals.

PROPERLY SET UP AND FULLY POSITIONED: Double easy access to and from the lot to the Lodge. check all folding tables and chairs opened and in locked posi-

FLOORS & TRASH: Be sure floor surfaces are level and free of any debris, and have someone monitor trash cans, possible slip and fall hazards, and spills.

REALIZE THE GROUP MAY INCLUDE THE ELDERLY OR **PERSONS WITH DISABILITIES.** Make sure the Lodge is A D These are just a few helpful safety tips for your Lodge. A compliant and tables are easily accessible.

EMPLOYMENT PRACTICES: Every Lodge should establish and follow a personnel policy that provides a means for an employee to register a grievance.

- 1. Have they signed the Lodge Non-Disclosure and Harassment forms?
- Have they read and signed Lodge employee hand book?
- Are their W-2s properly filled out?

SERVICE OF ALCOHOL: Only trained bartenders, employees and volunteers, may serve alcoholic beverages to members and their quests.

- Are they TIP or TAM trained, and posted in Lounge?
- Have they been instructed on how to talk with Local Liquor Inspectors?
- Do they have access to the Emergency call list?
- Have they been trained in any emergency exit instructions? If they think 911 should be called, DO SO.

FOOD SERVICE: All health department rules must be observed in the Lodge kitchen. A clean kitchen in good repair is vital to a successful Lodge. Keep equipment in good repair. Perform routine preventive maintenance. Assure all pilot lights are lit. Maintain all Carbon Monoxide detectors. Do you have a grease trap? Have it treated with a biocide to relieve possible grease clogs? "A Clean kitchen, is a happy kitchen."

SIGNING DOCUMENTS: Documents must be reviewed by the Lodge attorney before a Lodge officer or anyone signs a document that obligates the Lodge to indemnify or hold another party harmless. At least have your Trustees review and address any unanswered questions.

LODGE FURNITURE: Inspect all chairs, stools, tables and equipment, and remove any damaged or worn items from the premises. Retain all records from the purchase of replacement items. If it is broken, fix it. If it can't be repaired, toss it. Do not give it away or donate to anyone.

DANCE FLOORS: Clean up spills and debris promptly and avoid applying slippery substances on the dance floor since it may contribute to falls. Have floor monitors at Lodge affairs and rentals. If you have A E D's, have they been P M'd and

PARKING LOTS: Repair any holes and broken pavement FOLDING CHAIRS AND FOLDING TABLES MUST BE promptly. The parking area should be illuminated to permit

> Are your Lodge Liability signs in place or do they need to be replaced? Always maintain icy patches, treat, or mark them. Do you have Parking Lot monitors? Or, Security at Lodge Rentals? Help seniors or disabled persons to their car. When leaving late or closing the Lounge, go in pairs. Do not leave the Bartenders alone.
