Failure to update records can, and probably will, cause membership totals to be out of balance in the Chicago Lodge Membership System (CLMS2Web).

Also, the Financial Reporting System (FRS) monthly and year-end financials must be filed by

**March 31** [GLS: Section 13.040, 1.(g)], then every third Friday of the month thereafter. A Lodge's failure to comply with the new FRS program can result in fines being assessed. [GLS: Section 13.040, 2.(c)]

The input of required data for the yearly charity report must be provided and submitted by, on, or before **May 1** via CLMS.

I found that the best State Association websites tended to include:

- a calendar of events,
- current newsletters,
- details about upcoming events,
- information on conventions with registration forms and reservation information,
- Lodge directories with meeting dates and times, and
- lists of state officers and committee leaders with contact information.

Membership information is very important to those wanting to join or reinstate. After all, we all need more Members, don't we?

Other great ideas I saw on the websites included a newsletter archive; procedures and training manuals; supply forms and shirt order forms; bylaws; and minutes of meetings.

I spotted some issues with State Association websites, too. Webmasters should remove discontinued pages, old information, and pictures from 10 years ago. The biggest flaw in all websites was the lack of current information, news, and photos.

**GRAND LODGE GOVERNMENT RELATIONS COMMITTEE****What does a Government Relations Committee do?**

The work being done by your Government Relations Committee is essential to maintain our status as a non-profit, tax-exempt, private charitable organization, and is vital to the very survival of our great Order.

Members may wonder, What do people involved in Elks government relations do, exactly?

**Lodge Chairperson:** Establishes contact with legislators who represent their areas, providing them with information and charitable data and statistics concerning various Elks activities.

**District Chairperson:** Monitors legislative activity of the local government, encourages active involvement of the Lodges in their districts, and establishes contact with legislators in their districts.

**State Chairperson:** Shares information they receive with their district/Lodge chairs and with their Grand Lodge Area Members.

**Grand Lodge Committee Members:** This group is composed of eight members, one for each of the designated Grand Lodge Areas throughout the country.

There are seven main functions of the Government Relations Committee.

**1. Charitable reporting.** Ensure the charitable work being done by our Members, Local Lodges and State

Associations is reported as part of the Grand Lodge Annual Report.

- 2. Monitor legislation and laws.** Watch for any proposed legislation or governmental action that might in any way affect our Order.
- 3. Advocate for or against legislation when necessary.** Advocate for legislation that would help our Lodges and oppose any legislation or governmental action that would affect the ability of our Lodges to operate. Work to change existing laws when necessary for the benefit of the Order.
- 4. Promote programs between Lodges and their elected officials.** Develop interactions with federal, state, and local officials and agencies.
- 5. Educate Members on public accommodations and other laws.** Educate our State Associations and Lodges about existing laws that affect their day-to-day operations and how to comply with these laws and regulations.
- 6. Assist Lodges with IRS audits.** What to do in case of an IRS audit?
- 7. Social networking/media.** Assist Lodges to protect themselves when using social networking and all types of media.

Charitable reporting is necessary for our Order's survival. This is the only documented proof of the dollar value of the charitable work the Elks do.

The Lodge Secretaries have forms available with name, hours, mileage, and activity listed for Members to fill out when they volunteer for an event the Elks support at the Lodge or in the community. The Lodge Chairperson should let the Members know there is a volunteer sheet, and tell them why logging their volunteer hours helps the Lodge. Make sure it is in a location that is accessible for everyone. There should also be a list of activities that qualify. Did you know that attendance at Grand Lodge and State Association Conventions qualify?

We do this to keep our 501(c)(8) tax exempt classification status. Make sure to log information of non-Members who also volunteer.

When congress, your state legislatures, and county and municipal governing bodies are in session, keep watch for changes to laws affecting discrimination and harassment; U.S. postal regulations; sales tax and exemptions; alcoholic beverage control rules and regulations; bingo, raffles, and games of chance rules and regulations; and property tax exemption laws. All Lodges' day-to-day operations are affected in some way by these rules in their state and locations.

I hope this information gives some insight into what government relations is all about. I wish all the officers the best of luck for the coming year.

With spring now here and summer just around the corner, our Lodges need to step up and help rejuvenate our old youth programs and promote new ones. Our Hoop Shoot, Soccer Shoot, and Junior Golf programs are ideal for the Lodge to become involved without a major financial effort.

The Junior Golf Program provides your Lodge an excellent opportunity to interact with area youth through fun, instruction, and participation. It also serves as an excellent pastime to get our children away from all of their electronic devices for a time. For your Lodge, a program can be as simple as contacting your local golf course and working with the course's golf pro to set up a program for teaching young golfers skills and etiquette. The Lodge can also



collaborate with existing national and state programs.

Nearly every state has a junior golf program, including lessons and competitions in which the Lodge can participate. Here are a few national programs available to the Lodges.

**• Drive, Chip & Putt Championship** is centered on the fundamentals of the sport. Competition starts in May and runs through August, ending with the top 80 youth competing at the Masters. ([drivechipandputt.com/](http://drivechipandputt.com/))

**• First Tee** introduces the game of golf and its inherent values to young people. ([thefirsttee.org](http://thefirsttee.org))

**• American Junior Golf Association** partners with USGA to present the Leadership Links program, which encourages young men and women to develop charitable giving skills and service-oriented practices. ([ajga.org](http://ajga.org))

**• USGA** produced some guides for non-profit golf programs over the years. ([usga.org](http://usga.org))

**• PGA Junior Golf Camps** have nearly 180 locations nationwide, all with world-class PGA facilities. ([pgajuniorgolfcamps.com](http://pgajuniorgolfcamps.com))

We were pleased that 37% of the ERs knew the name off the top of their heads. A few responses we got were:

- "The D.A.R.E. officer at our school is."

However, that meant 63% did not know. Exalted Rulers are winding their year down in the next few months, but drug and substance abuse never winds down! If we learned one thing during the COVID pandemic, it's that drug abuse increased. Now is not the time to let our foot off the gas.

Thus, the directors of the DAP are issuing ERs the following challenge:

**Two Lakewood Lodges, one warm winter**

Of the 30 places in the United States named Lakewood, five are home to Elks Lodges.

Roughly 1,800 miles apart, the Lakewood Lodges in New Jersey and Colorado used Community Investments Program grants to help their communities prepare for the cold months with children's winter coat giveaways.

Lakewood, CO Lodge No. 1777 used its Beacon Grant to purchase 140 coats in many styles and colors for children in preschool through sixth grade.

"The kids were so appreciative and thankful they could have a coat," said Grants Coordinator Venita Collier.

The Lodge distributed nearly 100 coats over two weekends. The remaining coats were brought to a local elementary school where they were given to students who couldn't make it to the Lodge.

"The reason I joined the Elks was for the charity," said Collier, who has led the Lodge's CIP projects since 2005. "This is one of the projects with the most need that I have done."

Around the same time, Lakewood, NJ Lodge No. 1432 held its own coat event.

With the help of a Gratitude Grant, the Lodge purchased about 200 coats, and they gave away every single one at the event. After the event ended, the Lodge purchased 35 more coats for children who couldn't find one in their size.



"The very next day as I was driving to work, I saw kids waiting at the bus stop proudly wearing their new coats," said Joe Barina, the Lodge's Exalted Ruler. "It was then that I knew what we did made a difference."

Both Lakewood Lodges were heartened by the success of their projects, and both anticipate repeating them next year.

"Our Members thought this was fantastic," Collier said. "All the volunteers felt it was such an honor to do this."

# Don't let our treasured veterans suffer chronic hunger

As you know, the Elks support of our veterans goes back over one hundred years, even preceding the formation of the Elks National Veterans Service Commission 75 years ago. While we have achieved great success in helping those who have served, we still have much more to accomplish before we can rest on our laurels.

One area that receives little publicity is chronic hunger among our veterans. The U.S. Department of Veteran Affairs (VA) defines food insecurity as a lack of access to sufficient food to support and sustain a healthy lifestyle. A study completed

in 2021 by another federal agency, the U.S. Department of Agriculture, found that from 2015 through 2019 more than 11% of all "working age" veterans—that is vets between the ages of 18 and 64—live in food insecure households. It is clear that food security is critical for the well-being of our veterans.

Our government has stated that food insecurity is a problem that impacts 1 in 8 people in our country. Furthermore, one-fourth of active-duty military and reserve members have had to rely on food bank donations to help feed their families. A

recent survey by the Blue Star Families organization identified that 14% of active-duty household respondents reported facing difficulty putting adequate food on the table during the previous year.

What can we as Elks do? We can implement programs that many Lodges are already doing in their communities. Here are a few suggestions as to how our Elks Members can help.

- Support your local food pantry to help veterans get access to healthy food.
