**Remember:** This information is to be filed via CLMS2Web. Please, do not mail to Grand Lodge or your District Deputy.

With the pending automatic submission of the Annual Membership Report, all membership activity must be entered in CLMS2Web by 11:59 p.m. Central on **March 31**.

What does that mean? All membership records (additions, drops, and deaths) must be finalized. If not, the Lodge membership total will be out of balance.

The Grand Lodge Fraternal Committee would like to remind you that the Lodge year is quickly coming to an end. There is still time to enter the Contest 'A' - All American Lodge Contest for the 2022-2023 year.

We all know that the All American Lodge is the most prestigious award that Grand Lodge issues, so I hope your Lodge is busy preparing your entry.

To get started on the application, go to: [elks.org/grandlodge/fraternal/files/contestALodgeCertification.pdf](https://elks.org/grandlodge/fraternal/files/contestALodgeCertification.pdf). You will find everything you need. Just print it out to begin.

It is very important that you read

the entire form carefully, including the requirements and descriptions. Make sure you have strong supporting documentation, which is very critical for point value. If you are not sure you qualify for something, check with your District Deputy. Every point is extremely important!

You can use a separate sheet or the back side of the form to list all your different activities. The Lodge Secretary must verify Lodge membership as of March 31, 2022. This will determine the division in which you will be judged. Also, make sure your entry is signed by the Exalted Ruler and Lodge Secretary, and postmarked to your District Deputy by March 15, 2023. This will ensure your Deputy has time to review it before sending it on to your State

Lodge Activities Chairman by April 15, then on to Grand Lodge with a postmark no later than April 30.

This award shows that your Lodge is working as a team. Officers and Members working together is how Lodges thrive and strengthen community relationships. Building stronger ties shows cities and towns how Elks working together can accomplish amazing things.

If you don't think you qualify this year, it is not too early to start planning for next year. Start a committee, go over the form, and start recording your entry. You will be surprised at how many things you can improve and build on.

I'd say good luck, but that's not necessary—hard work and effort have nothing to do with luck.

# Roles and structure of Gov. Relations

The undertaking of your Government Relations Committee is necessary to maintain our status as a nonprofit, tax-exempt, and charitable organization.

The structure of the committee is as follows.

**Lodge Chairperson:** Establishes relationships with local legislators and provides them charitable statistics concerning various Elks activities.

**District Chairperson:** Tracks legislative activity of the local government and encourages involvement of the Lodges in their districts.

**State Chairperson:** Shares information they receive with their district and Lodge chairs and with their Grand Lodge Area Members.

**Grand Lodge Committee Members:** This group has eight members, one for each of the designated Grand Lodge Areas throughout the country.

There are seven main functions of the Government Relations Committee.

**1. Charitable reporting.** Ensure the charitable work being done by our Members, Local Lodges, and State Associations is reported as part of the Grand Lodge Annual Report.

**2. Monitor legislation.** Report any proposed legislation or governmental action that might in any way affect our Order.

**3. Advocate for or against legislation when necessary to protect our organization.** Work to change existing laws when necessary for the benefit of the Order.

**4. Promote programs between Lodges and their elected officials.** Develop interactions with federal, state, and local officials and agencies.

**5. Educate Members on public accommodations and other laws.** Educate our State Associations and Lodges about existing laws that affect their day-to-day operations and how to comply with these laws and regulations.

**6. Assist Lodges with IRS audits.** What to do in case of an IRS audit?

**7. Social networking/media.** Assist Lodges to protect themselves when using social networking and all types of media.

Lodge Secretaries have access to shareable forms to track hours, mileage, and activities listed for Members to fill out when they volunteer for an event.

The Lodge Chairperson should let the Members know there is a volunteer sheet, and explain to them the importance of logging their volunteer hours.

We do this to keep our 501(c)(8) tax exempt classification status. Make sure to log information of non-Members who also volunteer.

I hope this information gives some insight into what Government Relations is all about.

# Washington Lodge makes Impact in childhood literacy

The Community Investments Program offers Elks an opportunity to address the most pressing needs in their community. Last year, more than 80% of Elks Lodges used at least one CIP grant as the ENF awarded more than \$11 million.

But CIP grants are worth more than their dollar value. These grants can turn Lodges into a community force. Every \$1,000 granted last year put nearly five Elks in the field, volunteering more than 26 hours on community service projects.

“When we pair our resources with passionate and dedicated volunteers,” said ENF Assistant Director Debbie Doles at the 2022 Elks National Convention Opening Ceremony, “the result is powerful.”

The ENF reignited its Impact Grant program after a brief COVID-induced hiatus, and 56 Lodges were given up to \$10,000 to implement large charitable projects in their communities. Bremerton, WA Lodge No. 1181 used its Impact Grant to be a force in its community.

Bremerton Lodge’s Impact Grant project, Reading for Readiness, helps kids develop reading comprehension, disaster preparedness, and social-emotional skills like anger management, making friends, and handling worries. So far, they have already given 4,000 books to kids living in households below the poverty line.

Bremerton Lodge’s Grants Coordinator and Exalted Ruler, Heather Beal, and another Lodge Member, Gus Holstein, sat down with the ENF to talk about the grant project in a video that premiered at the convention’s Opening Ceremony.

“We’re so proud of the work the Lodges are doing with our grants, and there are a lot,” Doles said in her speech. “For those who aren’t taking advantage of all the available grants, I urge you to take heed of what Gus and Heather said at the end of that video: Find a need in your community that’s not already being met and use our grants to do something about it.”



# Army of Hope eases life's stresses for military members

In February 2003, the Elks announced the Army of Hope program to assist military members, including active duty military personnel, deployed units, military reservists, the Coast Guard, the National Guard, and their families.

The Army of Hope allows the military member to safely concentrate on his or her duties without worrying about the family at home.

It has many facets and can be easily adapted to the needs of local families. Lodges partner with local and state organizations, VFWs, churches, and

scout groups to adopt units and families to help them through these trying times.

The first step, like with many projects, is to gather some volunteers. After you have established your Army of Hope volunteers, contact local groups like Reserve and National Guard units, Blue Star Family groups, and other groups for military members. Ask what their biggest struggles are, and offer examples of things your Lodge can do to help. Military families may contact the Lodge or volunteers directly, depending on how you set up the program.

Examples of aid assistance include:

- School lunches
- Medical and dental emergencies not covered by insurance
- Minor home repairs (plumbing, electrical, painting, etc.)
- Auto repairs or transportation when needed
- Full-time or back-up babysitting
- Lawn mowing, snow shoveling, landscaping, sprinkler repairs
- Clothing and shoes
