Dear Maryland, Delaware, and the District of Columbia Elks and Friends:

Hope all MD, DE & DC Elks and their families are doing well and that the 37 Elk Lodges across the Association are prospering and on track to make the goals and objectives set at the beginning of this 2023/2024 Lodge year. We are already into the 6th month of this Lodge year, meaning we still have almost seven months left in the year to accomplish our goals and objectives and get things done.

Membership remains our top priority, and we are on track to have another year of overall growth. If so, it would be three years in a row and a fantastic trend we want to repeat again and again. In my message in last fall's newsletter, I mentioned that in the 2021/2022 Lodge

year, our Association had an overall gain of 483 members – the highest gain in 37 years. Well, the 2022/2023 year was even better, and we attained a gain of 549 members – a fantastic job by all who worked so hard to make it happen two years in a row. Right now, we have added (or have gained) 815 members as opposed to a gain of 716 this time last year – almost 100 members better than last year at the same time – great effort to get new members on board!!

However, our delinquency is currently at 2,239 as opposed to 2,048 this time last year - we have work to do here, and it has to be addressed and improvements made on an individual Lodge basis.

While our Association wide delinquency rate (11%) is a bit better than the national average (11.7%), we need to get it in the 3-5% to attain membership growth on an ongoing and routine, year-after-year basis – only three of our Lodges fall into that category today. Seventeen of our Lodges exceed the national delinquency



rate, with one over a 25% delinquency. Needless to say, individual Lodges need a major push over the next seven months to get our delinquency in line and not an issue at the end of the year. We are doing a great job getting new members on board but a dismal job keeping them after they have been initiated. Every Lodge must continually make each member feel welcomed, wanted, and needed, giving them positive reasons why they should continue paying dues and maintaining their active status as an ELK.

We currently have 408 candidates in the pipeline to be imitated. When that happens, our gain will stand at 1,223 – every ELK, every Lodge must diligently work on the delinquency issue, and at the same time, Lodges must Initiate, Initiate, Initiate.

ENF donations are another area where the individual Lodge donations add up to give the overall Association numbers and sought-after, high national per capita ranking. Through August 27, 2023, our Association is ranked 13th of the 48 Associations of the Order, with \$90,288.49 donated by our 37 Lodges, yielding a \$4.465 per capita.

At the same time last year, we were ranked 8th with \$117,390.73, having been donated with a per capita of \$5.965. We are about \$27,000 behind where we were a year ago and need to pick up the pace a bit. No one wants to see us regress and go backward in our per capita and total dollars donated to ENF. We have seven months to get back on track and improve our dollars donated and, thus, our overall ranking. Again, this can

only be done by the individual Lodges – each and every Lodge needs to step up their efforts to raise funds for ENF and help get our Association back on track to enjoy a high ranking in per capita donations to ENF – hopefully, a bit higher than last year.

It was good seeing many MD, DE & DC Elks at the National Convention in Minneapolis in July. Thank you to all our Lodge leaders who attended. This Convention, as reported by many, was one of our best and provided ample opportunities for Lodge leaders and members to learn about the Elks, how to do things in their Lodges, what the requirements are to be successful and operate a Lodge properly, and of course, have fun in the process. I am happy to report that only three Lodges were not represented at this Convention.

There are legitimate reasons why a Lodge may not have a representative at the Convention in a given year or at every meeting conducted during the year within the Association. Still, it should be the exception and never the norm. Each Lodge requires responsible leadership who do their very best to fulfill their individual Elks' duties and responsibilities, as well as see that the operational requirements of their Lodge are routinely met.

The norm is and must be that all Lodges are routinely represented at National and State Meetings, District Clinics, and Caucuses. We all must stay informed, know what's happening, and understand what the Elks are about. Routinely attending the National Convention, our State Meetings (Conventions and Con-

ferences), and Clinics are an excellent way to help do that and have fun at the same time. For some of our leadership, it is mandatory that they attend the National Convention and Clinics, but every responsible Lodge leader should want to participate in these meetings, etc., to represent their Lodge, learn through the process, and enjoy the social aspect of the get-together.

I look forward to routinely seeing the majority of our Lodge leadership as well as other Lodge members at our various get-togethers in the Association.

Speaking of get-togethers, at this fall's Conference in Ocean City (September 29 - October 1, 2023), we will be hosting New Jersey Elks State President Joseph Pedone, his wife Beverly, Pennsylvania Special Deputy Dennis Kanouff, his wife Jean, and Grand Inner Guard Bill Buttrill and his wife Joy. Please join Jane and me in extending a warm welcome to all three couples and be sure to let them know how you, your Lodge, and our Association are promoting Elkdom across Maryland, Delaware, and the District of Columbia.

Stay safe and well, and best wishes to all for a most enjoyable Fall Conference. Jane and I look forward to seeing you all there. Keep up the good work, and thank you to all our MD DE & DC Elk family for your continuing dedicated efforts on behalf of your Lodge, our Association, and our great Order.

THE BPOE DRUG AWARENESS COMMISSION AND OUR CONTINUED RECOGNITION OF RED RIBBON WEEK

Red Ribbon Week encourages our entire community to adopt healthy, drug-free lifestyles. The Elks Red Ribbon Week campaign brings together parents, schools, and businesses as we look for ways to keep kids and communities drug-free.

In 1985, Drug Enforcement Administration Special Agent Enrique S. "Kiki" Camarena was tortured and killed by drug traffickers. Shortly after his death, citizens from his hometown of Calexico, California, began wearing red ribbons to remember him and commemorate his sacrifice.

The first official Red Ribbon Week celebration was created by the National Family Partnership in 1988. Soon after its creation, the BPOE joined the NFP and other organizations in promoting the Red Ribbon campaign for families, schools, and communities nationwide each year.


The Elks continue to work within the national drug prevention movement, promoting this special week as part of their ongoing drug abuse awareness programs. For Elks members, the red ribbon symbolizes a continuing commitment to reducing the demand for illicit drugs in our communities. Red Ribbon Week gives us the opportunity to be vocal and visible in our efforts to achieve a drug-free community.

Research shows that children are less likely to use alcohol and other drugs when parents and other role models are clear and consistent in their opposition to drug use and the misuse of prescription drugs.

We encourage every Lodge to participate in this important annual event by planning and sponsoring a Red Ribbon event or distributing Red Ribbons and pamphlets. The DEA has created materials to help your school and community participate in Red Ribbon Week. The online toolkit includes a variety of helpful resources, including downloadable graphics, a fact card, student and parent pledges, and ways to promote Red Ribbon Week in your school or community.

Welcome all to the Fall Conference. It is always a pleasure to spend some time with our friends and Elk Family we see just a few times per year.

We ended our 2022/2023 year on a successful note. We finished 11th in the nation and were rewarded at the Grand Lodge Convention; with a favorable seating location, and an award presented in front of the entire assembled convention.



It was my honor and privilege to accept this award with President Rivituso and PSP Mary Cardinal-Vogt. It is always a great pleasure to attend a Grand Lodge session, much fun was had with new and old friends. We even managed to weather a heinous bird napping incident $\ensuremath{\textcircled{\odot}}$

Here are some numbers to consider. We started the year with 19,679 members, and we ended our year with 20,222, a gain of 543. This is the final number for last year as the adjustment/reinstatement period has ended.

Our Order added 78,382 new members last year, a new record for us. We have had a positive growth for two years in a row, we are now going for three years in a row, which has not happened since 1977.

So far this year, we have added 1,039 members, including reinstatements and transfers on top of initiations. This will increase before we meet, as I am preparing this article in late August.

Grand Lodge has a goal for each State to add 10% of its starting number as new members. For MD, DE, & DC, that would mean adding 1,968 new members for last year. For the

year we added 2,134 new members, so we have exceeded that goal. For the current year we will need to add 2022 new members to meet this goal, we are well on our way to that performance again.

There is no substitute for an active membership committee. As mentioned in the Grand Lodge "Plus Membership" program, we need our committee to be a "team". Lodge Secretaries, you can give "read" access to CLMS to your Lodge membership chairs, making it easier for them to stay current on who needs to be contacted. Membership committee folks should become familiar with the Membership and Marketing guides, which are part of the "members only" part of Elks.org.

We have a valuable resource available now, it's Join.Elks.Org. Prospective members can learn about our Order, and even apply online through this site. Another program available online is a photo opportunity. Get a group photo of the new members and email it to Rick Gathen (rickg@elks.org). He will send back a photo of the group digitally framed with a picture of our GER Randy Shook giving them a warm welcome. This photo is printable, can be sent to each new member, and can be included in your Lodge communications. Our new Grand Exalted Ruler graciously offered to continue the program, updated with his photo.

Another new benefit was presented at a membership/marketing seminar, and it is the new artwork available on the social sharables page. There are thousands of editable, premade items on this site that can be used by any Lodge in our Order. They cover almost any imaginable event you can have, and also routine Lodge functions such as meetings or initiations. They also have a staff who can make artwork for events not listed on the site, email a request and you will receive a reply within 3-4 days.

If you have never used Elks.org, simply open the webpage, look for the tab to register, and follow the instructions to register, and you'll be all set.

At the end of last year, we left 389 candidates waiting. We currently have 445 folks awaiting initiation. An initiation does not have to be part of a Lodge meeting, it can be held as a stand-alone event at any time. You can invite family members of the candidates to attend and witness the initiation. Have a social event afterward for the group if possible. There are many ways to schedule the initiation as part of a fun day or evening.

Congratulations to our leaders in recruitment and initiations. Our current leaders are Cape Henlopen, Ocean City, Wilmington, and Salisbury. I will report with up-to-date numbers when we meet. Many Lodges are also getting reinstatements and transfers, easy additions, these folks are already Elks.

K9s in a variety of ways, from apprehending to rescue and gives training to the handlers in case the dogs are injured in the line of duty. Towson Elks donated \$250. Elk members volunteered as guest bartenders.

Towson donated \$100 to the following charities: Arts for Learning, Evergreen Heritage Center, the Leukemia Lymphoma Society of MD, and United Way of Central MD.

The Lodge also raised from their giving board (through donations/tips in the Lounge) \$358 for The PAR FUND, which benefits law enforcement and their families who need financial assistance, \$145 to The Yes Foundation, which teaches children the benefits of art and music, and. \$128 to Camp Horizon Baltimore, based out of Boys Latin High School, which provides activities for kids with cancer.

We all know the West is Best, and here are a few highlights of the great things our West District Lodges have been doing:



"INSURANCE AND MARIJUANA, WE'LL FIGURE IT OUT."

Welcome back to Ocean City and the 2023-2024 State Convention! Did you have a problem finding the State Accident Prevention guy in this bulletin? Yes, I have updated my picture from 2007 to a 2017 job site. Now you know what to look for next time.

Since returning from Minnesota, I have received many phone calls concerning our insurance increases and how they determine what each Lodge owes for the year. I have been busy via phone and emails with Grand Lodge, trying to get you some answers. I will report on this during our business session this weekend.

News Flash! Marijuana is now legal in the State of Maryland, Delaware, and DC for medical and recreational use. This is limited to consumption inside one's residence. If you work on a Government Installation, you should notice a big sign that states: "Cannabis is still illegal on this base!" We need to take the same stand as our Lodge.

It is private property, and it is illegal to smoke weed for any medical or recreational purpose. We need to adjust our bylaws and House Rules and post a notice stating that it will not be tolerated at our Lodges. Hall Rental Agreements also need to be revised for this issue.

A violation of this stipulation should result in a loss of the security deposit and immediate termination of the Rental Agreement. No exceptions. We can still be held just as responsible for a stoned driver as an intoxicated driver.

I would first like to congratulate the Lodges that have been keeping their filings of reports with the FRS on a timely basis.

We do have some problems with a few Lodges, which I will not name in this newsletter, as they know who they are. But at present, seven (7) Lodges have not filed a 23 / 24 Budget with the FRS, which was due by May 26.

We have six Lodges (6) at least four months (or more) behind on filing their actuals with FRS. The July reports were due on August 18, and the August report is due on September 22. Please get your Lodges up to date with the FRS reports.

I don't know if everyone is aware that in the 2022 Statues, in Section 13.040, there is an addition to the Statue that was not there in 2020, which is # 2: Financial Reporting System Local Lodges Requirements and Compliance. I suggest you read this section, as there are now fines for all FRS reports not filed on time, as written into the 13.040 statute.

All Lodges should have filed their 990's with the FRS, which were due on August 1. If you have not submitted your Lodges 990's, please do so.

I will be sending out monthly reports to the State District Chairs, and the DDGER's and with our Advisors and State Sponsor. You may contact me at the above number and email anyone with any questions.

The Most Valuable Student Scholarship Contest began on August 1, 2023. The deadline for entries is November 13, 2023, at 11:59 pm Pacific Time.

At the conclusion of the national contest in April, ENF will award 500 four-year scholarships. The top male and female winners will receive \$50,000 each, the top 20 finalists will receive \$30,000 each, and the remaining 480 semi-finalists will receive \$4,000.

The top male and female winners for the 2023 Contest were both from Maryland; Diya Jha from Frederick Lodge, and Agam Igwe represented Towson Lodge.

The two eligibility requirements are a high school senior and a citizen of the United States.

Applications are judged on leadership, academic achievements, community involvement, and financial need. ACT and SAT standardized test scores are no longer required.

The Grand Lodge Committee on Judiciary (COJ) is a hard-working, dedicated group of Elks leaders. As I enter my third year of service on the COJ, I have a firm understanding of the Committee's work, as well as the time commitment required. These eight (8) attorneys—one from each Grand Lodge Area—are a busy group indeed, working (often daily) to oversee the legal affairs of the Order. Approving by-laws, answering questions, litigating Grand Forum cases, and both proposing and discussing possible changes to statutes, among other things. It is good, challenging work, and I consider it a privilege to continue my service to the Order and assist all of you.

In the off chance that any of you listened to my legislative "preview" in the run-up to the Minneapolis Convention, then you heard me speculate that Minneapolis promised to be a busy convention, legislatively speaking. As it turned out, the 2023 Grand Lodge Convention did not disappoint. A total of eighteen (18) resolutions were proposed and ultimately made it to the floor for final consideration, with ten (10) resolutions coming from the COJ and eight (8) more from Lodges and state associations. Between proposed per capita credits, requiring Treasurers to attend DD Clinics, and redefining the term "spouse", the legislative session in Minneapolis was a weighty one.

In this article, I wish to review a "sampling" of changes that will be of interest to state, district, and local Lodge leaders throughout Area 2. Now, please do not mistake my words or the purpose of this article. All changes to the Laws of the Order are important and a conscientious officer ought to take note, as officers are the best conduit of information to your Lodge's members. However, some legislative outcomes are simply more immediate, impactful, and important, and those changes I wish to discuss with you now.

First, I will discuss one resolution that did NOT pass but, boy, did it catch some attention. Resolution 2023-13 would have provided a credit to Local Lodges for all per capita payments paid to Grand Lodge by a Local Lodge, where that member failed to pay his or her dues during that Lodge year. Whether you agreed with the proposal or not, the outcome means we all continue on status quo ante. Local Lodges must still pay per capita payments to the Grand Lodge, based on the Lodge's membership list as of April 1st.

Second, changes have been made to the requirements for attendance at District Deputy Clinics. As mandated by Resolution 2023-07, Lodge Treasurers must now attend all District Deputy Clinics, just like the Exalted Ruler, Leading Knight, Secretary, and Trustee Chair. Similarly, Resolutions 2023-05, 06, and 07 (together) clarify that the District Deputy Grand Exalted Ruler possesses sole responsibility to grant excusals and exclusive authority to determine if "good cause" exists for excusal.

Third, in perhaps the closest vote of the legislative session, Resolution 2023-11 has redefined the term "spouse" to be those legally married (consistent with the laws of your

jurisdiction) or those in domestic partnership who have been cohabitating together for a period in excess of seven (7) years. NOTE: the purpose of this Resolution was NOT to expand the definition for those claiming spousal privilege but simply for use of the terms in publications at the Grand and Local Lodge level.

Fourth, Resolution 2023-10 put Life Membership requirements back on the table. I know many Lodges were surprised last year when the proposal to eliminate the age requirement (65 years) passed and became effective. For some Lodges, the cost of this change was significant and impactful to your bottom line. Resolution 2023-10 permits a Local Lodge to impose an age requirement for life membership, provided that age requirement is adopted in your Lodge by-laws. NOTE: you may NOT eliminate or withdraw a life membership already granted by adopting an age requirement in your Lodge by-laws. A life member now must remain a life member.

Fifth, a pair of proposals (Resolutions 2023-02 & 03) were passed overwhelmingly. These proposals now prohibit a member from using the "resources of the Order" (so Lodge building, membership list, social media pages, symbols/emblems, and the like) to fundraise for the purpose of participating in a Grand or Local Forum matter. If a member organizes or assists with such a fundraiser, that member can now be punished for doing so. In short, no Go Fund Me pages to raise funds to hire a lawyer to fight a Forum case. Don't do that.

Lodge leaders please note that Resolution 2023-01 was a proposed Constitutional Amendment, which did pass and was not controversial, but will require your Lodge to vote as part of the ratification process. The Grand Secretary will provide Lodges this information. You are required to hold a ratification vote (See Art. IX, Sec. 2 of the Constitution of the Order), so please don't forget and kindly follow through.

Some final thoughts before I conclude this article. All Elks should note that ALL—with the exception of Resolution 2023-01, the Constitutional provision—resolutions will become effective in thirty (30) days following passage, so on or about August 3, 2023. There were, of course, other proposals that were passed this year and still others that failed. I have elected to forgo a full discussion and review all legislative items in an effort to shorten this article. Should any member wish to review all the legislative items from the Minneapolis Convention, feel free to reach out to me.

In closing, if I can assist you in any way, do not hesitate to reach out. My contact information is available online (elks.org) and in most state association directories. I thank you all for the myriad ways I watch you—our Lodge leaders—serve your communities, our Lodges and members, and the interests of Order. You continue to do tremendous work.. We are "THE" Elks!
