There's more to come later this year, but now is the time to talk to your children and grandchildren.

Without a doubt, you still might have some reservations: "Will my children think I am too strict if I tell them not to smoke, drink, and use drugs?" Developing a strong bond with your children at an early age is important, but as the parent or grandparent, it is your job to provide the rules, structure, and discipline to raise a healthy child. Be a parent, not a pal. Set rules and consequences for breaking an addiction. Will you promise me you convention center.

This committee would be responsible for screening Teenager and/or Student of the Month

nominees in both junior and senior high posters, news releases and multimedia schools, selecting an outstanding boy and girl each month, and then yearly, giving them awards and publicizing their accomplishments.

Fillable certificates, signed by the Local Lodge Exalted Ruler and Youth Activities Chairman, may be downloaded in the Grand Lodge Activities Committee section of elks.org. If you have this program in place, honor those award winners in all categories with a special recognition activity at the Lodge.

The Grand Lodge Activities Committee page on elks.org has all the materials needed to implement a successful Youth Recognition Program in all areas. All the

videos are available to all Local Lodges, districts, and state Youth Activities Chairs to download. It includes the contact information for all Grand Lodge Activities Committee members and their areas of responsibility, plus those states they are assisting during the fraternal year. This is an excellent way to let our communities know "We Are THE Elks!"

The Fraternal committee has chosen this year's Americanism theme: "What does patriotism mean to me?"

This should prove to bring a wide variety of essays. We look forward to reading the different interpretations of this year's subject.

The contest has separate divisions for fifth, sixth, seventh, and eighth grade students. For each division, first place wins \$1,000, second place earns \$500, and third place gets \$250.

There are some important dates to remember. If you miss your deadline, your essay will be ineligible to win. Keep in mind all initial essays should go to the Local Lodge first for judging. It is important to communicate this information to your schools and teachers.

Also, you should send your essay to the Elks Lodge nearest to your home, and only to one Lodge! Each level of judging will send the top three in each division to be judged on the next level.

Deadlines

• Student/teacher sends essays to Local Lodge: No later than December 15, 2024.

• Local Lodge sends to District Chair: No later than January 31, 2025.

• District Chairman sends to State Chair: No later than February 28, 2025.

• State Chair sends to Contest Administrator: No later than March 31, 2025.

Rules

1. No more than 300 words. Essays must be typed or legibly printed in ink (by the entrant).

2. Must be submitted to the Lodge nearest their address.

3. The participant must be identified by name, grade, school attending, and the sponsoring Elks Lodge on the essay itself.

4. The cover page provided on our website must be attached to the essay. This cover sheet will follow the essay through each level of judging.

Judging and Scoring

1. Originality. Avoid the use of clichés and worn-out words and phrases. *30 points*.

2. Development of the theme. Stay focused on ideas and thoughts. Don't ramble. *40 points*.

3. Mechanics and neatness. Use proper spelling, grammar, and punctuation. *30 points*.

Publicize your contest via social media, newsletters, and e-mail blasts, as well as through local newspapers and radio. Prizes at the local level are also a good idea for increasing participation.

National winners of first, second, and third place in each division will be announced in our spring newsletter. Awards can be picked up at the Fraternal Committee booth at the 2025 Grand Lodge Convention in Kansas City, MO at the conclusion of session.
