### No blame game for child's addiction

Many volatile emotions erupt as a result of drug abuse and addiction, not the least of which is anger. It is not unusual for substance abusers themselves to feel angry, nor is it unusual for their loved ones to feel angry. Parents may feel angry about their child's addiction, and some parents may even go so far as to disconnect from their substance abusing child's life.

Parents are supposed to raise, nurture, protect, and empower their child until their child is independent. Even then, the parent's job is to continue to encourage and support their child, guiding him or her through life and the difficulties that may be encountered. When their child becomes addicted to drugs and the child's life slowly spirals downward, it's fair to say that the anger the parents are feeling may be anger at their own failure.

A common and unfortunate belief held by many parents of addicts is that they

are at fault for their child's addiction. Many parents who believe this will berate themselves for the path that their child has taken, believing that something they did or didn't do directly caused their child's addiction. They will spend many sleepless nights going over their parenting, attempting to find any minute detail that will back up their claim. They will say things like, If I had only been there for them more, or If I had only intervened earlier, maybe things would be different.

As understandable as this feeling is, parents are not at fault for their child's addiction. Knowing this will not necessarily make that much of a difference, nor will it even be that much of a comfort for the parent, who has to deal with the fact that their child has become addicted to substances. But, understanding that parents are not to blame will help bring a sliver of peace to an otherwise impossible situation.

Addiction is an illness that changes brain chemistry. A child may have made a choice to use an addictive substance, but we all make mistakes. The only difference here is that the child became addicted and lost control. It is not the parent's fault, and it's not the child's fault, either. Would you blame yourself if your child were born with another illness? You might try to find reasons to blame yourself, but ultimately you would understand that illnesses simply just occur and that no one is really to blame for them. You would fight hard to try to help your child in any way you could, but you would not carry the burden of guilt that parents of addicts carry.

The same applies with addiction. Your shamed-wh child may have been born with the genetic addiction/.

predisposition to become addicted. They may have grown up in a household where addiction was present; If this is the case, then own your difficulties, but this does not mean that you caused their addiction to start or that you caused their addiction to continue.

Parents who blame themselves for their child's addiction are not only spinning their wheels and going nowhere, but are more likely to lash out at their child-driving the individual who most needs their compassion, caring, understanding, and encouragement to withdraw further into their addiction. They will try harder to hide it since they feel that they cannot resolve it, and the gap between parents and child will open wider and wider.

Parents must realize that some difficulty in their child's life caused their child to turn to drugs. This does not mean that they have failed as parents, it means that they have an opportunity to really succeed as parents by helping their child overcome one of the most challenging difficulties life can present them. And it can be overcome.

# Emergency fund helps Vietnam vet through dark time

To honor Veterans Remembrance Month, here's a story about a Navy veteran who was featured in ENF's "Be the Spark" series.

Jesse has lived an incredible life. He married his high school sweetheart, raised 11 children, and is now watching 28 grandchildren and great-grandchildren grow up.

Intertwined in these moments of joy are painful memories. While serving on the *USS Guadalupe*, many of Jesse's fellow Navy comrades were killed during the Vietnam War. When Jesse returned home, he was diagnosed with PTSD. He also remembers when he received the call after his youngest son passed away. Ten months later, he lost his brothers who were twins.

"The thing with trauma is it always put me in a bad place," Jesse said. "I have been in some dark places in different times in my life."

Jesse always found a way to rise back up with help from the V.A., which offered mental health care and other services.

"If I didn't have the V.A., I don't think I would have made it through that," Jesse said

The V.A. referred Jesse to the Elks' Emergency Assistance Fund when the funeral costs for Jesse's son wiped out his savings.

"I didn't know what I was going to do," Jesse said. "I called on the Elks, and they came through for me."

The emergency assistance paid for a month and a half of Jesse's rent and helped him escape an eviction notice. Since receiving emergency assistance, Jesse has told other veterans and his friends at the V.A. about the Elks.

"I appreciate the Elks organization," Jesse said. "They're a Godsend. I will spread the word that you guys are there for veterans."

Since July 2015, the Elks National Foundation has contributed \$5.3 million to help end veteran homelessness. The money funds the Elks National Veterans Service Commission's Welcome Home initiative, which includes an Emergency Assistance Fund for veterans in eight metropolitan areas targeted by the V.A. for increased focus by the Elks. To date, the Elks have helped more than 1,350 veterans exit or avoid homelessness through emergency assistance. Learn more at enf.elks.org/WelcomeHome.
