

So where is it good to give 100%? Membership! This year's GER Class should be based on the motto, Creating Momentum for the Future of Elkdom. Get out there and recruit Members. But, recruit with the following things in mind:

1) The future of Elkdom relies on the age of our Members.

- 2) The future of Elkdom relies on future leaders.
- 3) The future of Elkdom relies on volunteers.
- 4) The future of Elkdom is dependent on us to create new and future Members. Give 100% to the best GER Class ever.

Another place to give 100%: ENF. This is ENF Month and with the raise in the amount of my goal to \$4.80, this is a great time to give 100%. How about giving 100% more than you did last year? There is no question the challenges we've been forced to face now, and over the past five months or so, have touched every Elk member in our Association as well as every Elk member across our entire Order. Unfortunately, it has pretty much touched all of us in an unpredicted, unexpected, and negative manner.

I want to thank each and every MD, DE, & DC Elks for hanging in there and carrying on the efforts necessary to keep our Lodges operating and in the game. It's certainly not been easy, but because of your efforts, we continue to operate as individual Lodges and as an Association on behalf of the BPOE and its programs across our local communities. Thank you! Thank you! Thank you!!!!

During these difficult times, it's certainly not been "business as usual" for any Lodge or individual Elk, and many are hurting in one way or another. However, it is certainly not all doom and gloom, and progress is being made daily as individual Elks and Lodges continue to "think out of the box" and do unusual/non-traditional things to cope with the situation and get the job done.

This 2020/2021 year is, and will continue to be, a most challenging year, but challenges are opportunities as well, and already individuals and Lodges are demonstrating there are many ways to get things done. In many respects and for some Lodges, we are in "survival mode." We are searching for and finding new ways to accomplish what needs to be done.

Two of the major ingredients for survival are membership and community relationship/involvement. Community relationship/involvement correlates directly to a Lodge's ability to attract and keep members. There are other factors required as well, but without sufficient membership and a community relationship, no Lodge can survive.

Over the past five months or so, it is evident many of our Lodges understand the community involvement component of being successful and have continued their community service programs and projects. Thankfully our ENF has continued to make CIP Grants available and, in some cases, broadened the scope of what they may be used for - all to help Lodges maintain their community involvement and presence, as well as Continued on page 4

help those in need in our communities. Hopefully, your Lodge, and every MD, DE & DC Lodge, is working on getting these grants to continue or start community programs/projects. If your Lodge has not done so yet, please do so now - it could be key to your long-term survival. An ENF CIP Grant certainly can't hurt your Lodge and, without a doubt, can help in its efforts to help others and/or to survive.

As I noted above, membership is one of the components necessary for the survival of a Lodge, and this year more so than any year in the past, membership retention is a significant issue. Since April 1, the statewide membership roles have increased by 200 members, with 310 candidates waiting for initiation even under the current circumstances, a petty dismal five months showing. We need to attract and initiate more members. On membership retention, with five months gone, we have 3,375 delinquent members. I don't need to tell you what dropping 3,375 members would do to the stability and longevity of many of our 37 Lodges. This potential problem can only be addressed and solved at the individual Lodge level.

Every Lodge must put a team together and start a campaign to convince every delinquent member that they are WELCOMED, WANTED, and most importantly, NEEDED if their Lodge and its important community work is to survive. Every Lodge needs the revenue a member brings to the Lodge in dues, and goods and services purchased, as well as the potential manpower. Every member represents the possibility to fill positions of leadership and/or the workers needed to do the many things required for a Lodge to function. There needs to be a continual and ongoing effort to build and maintain a relationship with every member who keeps the member wanting to be a part of the Lodge, what it does, and what it stands

Many times, members are delinquent simply because of the Lodge billing system or lack thereof. Perhaps they would like to use a credit card for their bills and/or they are used to being routinely billed, which most Lodges don't or can't accommodate. Well, Grand Lodge now offers an optional Billing Renewal Program where a contracted third party (OSG) routinely mails invoices to members and takes payment via credit card, etc. The cost to the Lodge is \$0.32 per invoice mailed - less than the price of a stamp and no work for overworked Secretaries. Suggest all Lodges look at this optional service on the Grand Lodge website; there is a webinar and detailed information about the program. Only what a Lodge does in building a relationship with every member can possibly eliminate delinguency. However, this service is a tool available to the Lodge that will, at a minimum, lower delinquency at little cost and no effort by the Lodge.

Our Fall Conference was just around the corner when I wrote this message. By now you know it had to be canceled

based on the number of reservations and other factors.

The election of our President-Elect was conducted electronically via an email process and congratulations to Vice President Elect, Robert Raleigh of Chestertown Lodge #2474.

While the first five months of 2020/2021 have had its share of roadblocks and obstacles. I am confident that the hardworking and dedicated Elks of our 37 Lodges can overcome almost any situation, and once again we will have an outstanding year. I would suggest as we work our way through these difficult and challenging times, we will, in doing so, develop a new "normal" with new tools/ processes/traditions and a better understanding of how to be successful individuals and Lodges. individuals, Lodges, and Order, we will be different, hopefully, improved, and ready to carry on our noble work of helping others.

Best wishes to each and every MD, DE, & DC Elk and their families for continued good health and prosperity. Best wishes to our 37 Lodges and their efforts to get through these troubled times and take the work of Elkdom into their communities. Hopefully, we will see you all soon as things return to our new normal in the near future.

# **ELKS TRAINING**

By Renee' Rivituso, PDDGER | State Chairman Elks Training Hopefully, our newsletter finds everyone well. As you know, It has been a sad year full of cancellations. During these months of COVID-19, many Lodges have been using their time wisely and doing some Spring cleaning. Good questions arose like, "How long do we need to keep membership records?" or "How long do we need to keep tax information?"

Membership records must be retained for all Lodge members, active and inactive. Membership records are kept for members within CLEMS, but hard copies are also necessary, especially for those members prior to the existence of CLEMS. Other permanent records include records of deeds, mortgages, member bonds, purchases of fixed assets, and depreciation records. All records outlined above should be kept indefinitely.

The Internal Revenue Service specifies minimum retention periods for certain records. Payroll Records must be retained for four (4) years. Income Tax Returns and Supporting Records must be kept three (3) years after the return is due or filed. Forms 990 and 990EZ must be kept for three (3) years for public inspection upon request. Be sure to check with your individual states regarding their retention periods.

More information on Record Retention can be found in Chapter 7 of the Auditing and Accounting Manual. Please be sure to use all the useful manuals provided to your Lodges. Digital copies of Elks Manuals and Statues can also be found on Elks.Org. Training Clinics will be available for all those in Lodge leadership positions in the month of November. # **ACCIDENT PREVENTION REPORT**

## DON'T BECOME MAYHEM LIKE ME

Good Morning Members of the Maryland, Delaware, and DC State Association. It's my honor to serve as your State Accident Prevention Chair for the upcoming year.

I will be submitting my reports to our Newsletter and sending out

occasional Safety Tips throughout the year.

Lack of Preventative Maintenance is the number one cause of accidents. By being proactive, we can reduce the number of claims and reevaluate our insurance coverage.

Example: It's now hurricane season, and if you have trees

around the Lodge, they should be inspected for disease and

rot and should be removed by a licensed and bonded contractor. If they are around power lines, you need to call the power company, and they will take them down for you. This will prevent many things from occurring, loss of power to the Lodge, loss of any computer components being fried when power returns, and any loss of perishables.

Establish as many contingency plans as possible for your Lodge. Take the monthly inspection reports seriously and expand on them.

Protect your Lodge from Mayhem, like Me!!

## **LODGE ACCIDENT PREVENTION MANAGERS**

Each Lodge shall establish an Accident Prevention Program in compliance with the Laws Of The Order, Section 12.070. A Trustee shall be appointed as the Accident Prevention Manager.

- Lodge Accident Prevention Managers must be involved in Lodge safety reviews.
- Lodge Accident Prevention Managers should be engaged in their Lodges' day-today operations.
- Lodge operations and safety reviews must not be delegated to employed managers.

## **REPAIR WORK AT LODGES**

Repair work at Lodges Issues to be addressed when there are repairs or construction at a Lodge:

- Get references from customers of the contractor.
- Check the contractor's past performance by contacting the Better Business Bureau or similar resource.
- Every contractor must provide proof (an insurance certificate) that the contractor has liability insurance
- Every contractor must prepare a written contract that will indemnify the Lodge from any claims arising out of the work.
- Projects involving extensive repairs and renovation require that the contractor name the Lodge as additional insured under its general liability policy.
- The Lodge should never take on the role of general contractor.


- Volunteers should not be performing repairs.
- No one from the Lodge should act as a construction manager/coordinator.
- Any Member that is a contractor must also have proof of insurance and prepare a written contract.
- When constructing a new building, putting on an addition, or making substantial renovations, the Lodge

must contact Aon Affinity Services at 1-800-421-3557 to make sure proper coverage is obtained.

## **FALL MAINTENANCE**

Fall maintenance accident prevention also involves

maintaining property when the seasons change:



- Make sure that smoke detectors are working and replace if necessary.
- Lodges that heat with gas/LP/oil need carbon monoxide detectors.
- Remove leaves from roofs, gutters, walkways and parking lots.
- Drain and store garden hoses for the winter season.
- Lawn sprinkler systems need to be blown free of water to avoid frozen pipes in the winter.
- Have chimneys and flues inspected and cleaned if necessary to reduce the risk of fire.

By a show-of-hands, how many people can give me a definition of "sectarian character?" No?

Let's try this: by a show of hands, how many people had even *heard* of "sectarian character" before becoming an Elk? No again? Well, if that is the case, why would you purposely embarrass your new candidate by asking him/her to say the words in the Obligation when they have never heard it before? Every one of you can recall a moment when the Exalted Ruler has been reciting the Obligation and has had to back up - at least once - to get the class through this particular stumbling block.

There is a very simple solution: make the reading and understanding of the Obligation a part of your Orientation. After all, this is a *promise* that the candidate is making to abide by the rules of being an Elk. Don't you read through a contract before you sign it? This is the candidate's contract with the Elks. Copy the Obligation, enlarged to 8 ½ x 11, and give every candidate a copy to keep.

During Orientation, practice the hard parts. You don't have to do the whole thing but provide them with an idea of what is coming. Same with the two questions: "Do you believe in God?" And "Are you willing to assume such an Obligation?" This is not rocket science. Make it easy for both you and the candidates to relax and enjoy the Initiation.

Speaking of Orientation, how many of you make a tour of your Lodge building a part of the Orientation process? After all, aren't you introducing the candidates to what it means to be an Elk? And, isn't this going to be their new "home-away-fromhome?" (Hopefully.)

How can a new Elk help with the Friday night dinners if they do not know where the kitchen is? How can the new Elk help with a "clean-up on aisle 3" if they don't know where the mops are kept? If it is true that "mi casa es tu casa," they must know their way around their new home.

How about the ballot box? During Orientation, the ballot box should be brought out and explained. Sure, the Exalted Ruler has a set monologue that goes with balloting on new members but how many people – hearing it for the first time – know what he/she said?? What does a black cube look like?

The idea of Orientation is to make the new members as comfortable as possible in their new role as "Elk Members." If you are only showing the candidates the video during Orientation, you are setting yourself up for a delinquency a year from now. Included in the Orientation should be a short oral history of our Order, how old we are, why we are so proud, and why the Lodge leader is called an Exalted Ruler. Are we the Knights of the Round Table? No. But the character of those knights is what inspired the Knights of Elkdom. Be proud of our history, embarrassed by the titles.

In short, think of Orientation as a conversation you are having with your best friend about all of the reasons to become an Elk. You wouldn't set your best friend up to fail, would you?

## Red Ribbon Week, October 23-31




Red Ribbon Week is the nation's oldest and largest drug misuse prevention awareness program.
