

the Members Only section of elks.org. Click on “Officers & Committees, then “Grand Lodge Committees” and select the Fraternal Committee. Under the “Currently Featured Contests/Awards” header there will be a link to the Fly the Flag Program & Certificate. The first page contains a letter from the current Fraternal Committee Chairman with instructions on filling out and printing the certificate, which is on the second page of the document.

Once you have printed the certificates, have your Exalted Ruler or Americanism Chairperson sign them. You can award these certificates at a formal ceremony or you can go to the businesses and present them. In any case, don't forget to notify the media. This is a great public relations opportunity for your Lodge and the Order. If no local media is available, take a picture with the business representatives receiving the certificate and submit it to your Lodge bulletin, State newsletter, and the Elks Magazine.

The presentation of these certificates will increase community awareness of the Elks and help get our message out to the community. There is no better way to show your Lodge is *“Meeting the Challenge.”*

# Drug-free messaging begins with good communication

First and foremost, the directors of the Elks Drug Awareness Program, their families, the State Chairpersons and their families wish a very happy holiday season to all Elks and their families. COVID-19 prevented many of us from being with you personally, but it did not prevent us from communicating with many of you. We look forward to a time when we can safely gather to thank you all for making your communities better and safer.

Here are a few things to remind you that COVID-19 did not stop the work of the DAP or the need to continually remind our youth of the dangers of illicit drugs:

- In an age when the speed of information can often outpace the speed of verification, the COVID-19 pandemic has taught us that it is crucial to cut through the noise and focus on facts, a lesson that we must heed in order to protect our communities from the impact of drugs. We do this through



a variety of Elks websites to include: [elkskidszone.org](http://elkskidszone.org), [elksteenzone.org](http://elksteenzone.org) and our new [elksdap.org](http://elksdap.org). Our national spokesperson, Ray Lozano, has been conducting webinars all over the country. National speaker Heather DiBlasi is available for Elementary Schools.

- Drug traffickers have quickly recovered from the initial setback caused by lockdown restrictions and are operating at pre-pandemic levels once again. Access to drugs has also become simpler than ever with online sales, and major drug markets on the dark web are now worth some \$315 million annually. Contactless drug transactions, such as through the mail, are also on the rise, a trend possibly accelerated by the pandemic. We encourage all Elks who

are concerned about this to visit [dea.gov](http://dea.gov) for more information.

- Communicating facts about drugs and promoting science-based interventions are an absolute necessity if we are to reduce demand and supply of drugs, while also facilitating access to controlled medicines for those in need. It is also the surest path to eliminating stigmatization and discrimination and providing adequate treatment, as seven in eight people who suffer from drug use disorders remain without appropriate care. While the Elks DAP is committed to informing youth of the dangers of illicit drugs and the abuse of other substances, we support communities that provide treatment and offer hope to those afflicted.

Entering the new year, the Elks DAP is committed to providing Exalted Rulers with an opportunity to lead their communities towards a drug-free society. We wish you all the blessings of the season and a very happy and prosperous 2022.

## ENVSC combats veteran homelessness

Many veterans face challenges after returning from service, and the Elks step up year-round to meet their needs.

According to the National Alliance to End Homelessness, 37,252 veterans experienced homelessness on a single night in January 2020. The Elks National Veterans Service Commission is dedicated to alleviating veterans' homelessness.

Through August 3 this fiscal year, the ENVSC's Emergency Assistance Fund helped 151 veterans exit or avoid homelessness, awarding \$262,931 in vital, timely aid. Of that total, 35 percent has gone toward paying rent, 31 percent to utilities, and 15 percent to other housing-related expenses.

However, getting veterans housing does not make the house a home, so the ENVSC's work is far from done. Welcome Home Kits provide veterans with small furniture, kitchenware, and cleaning supplies. This year alone, more than 70 Elks Lodges in 30 states have used \$170,185 to provide 623 kits to veterans.

Another way the ENVSC seeks to end veterans' homelessness is through Freedom Grants, which are competitive

grants awarded to Lodges to help Elks serve veterans and active-duty military members in their community.

Naval (Port Angeles), WA Lodge No. 353 is located on the Olympic Peninsula, which, according to the Veterans Administration, is home to 15,000 veterans—the highest per-capita percentage of veterans in the country.

"It is impossible to know for sure how many of those veterans are facing homelessness, but we know they are in our community," says Paul Collins, the Naval (Port Angeles) Lodge Grants Coordinator. "We want to be a central place that can be counted on year-round to provide necessary items to veterans."

To build this haven of resources, the Naval (Port Angeles) Lodge used a Freedom Grant to create a Veteran's Basic Needs Closet. The dedicated space at the Lodge stocks necessities like coats, gloves, hats, sleeping bags, backpacks, sleeping mats, hygiene items, and snacks for veterans in need.

# Emergency Assistance helps hundreds of veterans

A father with a heart condition is anxious to move his family to a safe, smoke-free home. A man worries he will be evicted from his apartment while receiving inpatient mental health treatment. After learning that her abuser is scheduled to be released from prison, a mom moves her children out of state on short notice.

If you're wondering what these people have in common, the answer is simple. All three are veterans, and all three turned to the Elks in their time of need.

The ENVSC's Emergency Assistance Fund was created to help veterans

prevent and exit homelessness. In 2015, in partnership with the VA, we pledged to help eradicate veteran homelessness.

The Emergency Assistance Fund is one way we are making good on that promise.

Last year, the Emergency Assistance Fund helped more than 400 veterans with essential housing expenses such as security deposits, rent, and utilities. For most of those veterans, Elks assistance was the only thing standing between them and homelessness.

Many people, including veterans, are one emergency away from the threat of

eviction: a job loss, an illness, a death in the family. Working at the ENVSC, I have witnessed firsthand the pivotal role of timely financial support in shaping a veteran's future. Even a seemingly small amount of money can help to keep a veteran safely housed.

Our Emergency Assistance Fund gives veterans the support they need and deserve to rebuild after homelessness or a financial emergency. The fund does something else, too: it shows veterans that they are not alone. "You have given me a renewed hope for

# Efficient new billing system dates saves Lodges money

Lodges in the new billing system are doing better in terms of retention than Lodges not in the system. The stats are also clear that the new billing system has made a major difference with only an 8% delinquency nationwide.

Further, the cost savings are even better now that USPS has increased its postal rates by 28% for the new year. The new billing system will remain at \$0.32 per mailing, thus saving our Lodges an average of \$0.80 per Members' dues invoice mailing.

We have also resolved all the issues that were identified by the Lodge Secretaries in 2020-2021. The new billing system is more effective, more efficient, and will save the Lodges more money in 2022.
