Dear Friends and Members of the MD, DE & DC Elks Association:

Well, here we are once again in the final weeks of the Lodge year. This is a hectic time for the Lodges, as well as Elk leadership and members at all levels, in our efforts to wrap up the year with positive gains in membership, program accomplishments, charitable giving, and financial performance.

In addition to closing out the year, Lodges are electing a new slate of officers for the coming 2024/2025 Lodge year and hopefully setting the stage for another successful year. For your Lodge and all our Lodges to succeed, prosper, and grow in 2024/2025 and future years, we need dedicated and capable leadership year after year. Hopefully, you have elected the best of the best into leadership positions.

Also, we are determining how many of our Hoop Shoot competitors will represent us in the National Finals in Chicago in April. Hoop Shoot Association Chair Dewayne Wilcher and his committee assure me that a number of the contestants in the upcoming Association Contest have the potential to make it to the Nationals—best wishes to all the competitors at all age levels. I am looking forward to seeing you all in Chicago in April.

Membership retention and growth for 2023/2024 is also in the

final "push" stage, with the deadline looming in just over a week. (March 31, 2024). Fortunately, the numbers as of 2/12/2024 already have our Association at a net gain of 44 members for the year without getting any of the 368 candidates waiting for initiation or recovering any of the 1,341 (6.6%) delinquents. That's excellent news and a "3 in a row" for our great Association. Evident as well is the potential "great" membership growth year. Our association can achieve this if we can initiate the 368 candidates in waiting and reduce the 1,341 delinquent number. We are on the plus side of the ledger, but don't let up now. Make this our greatest year for membership growth, and you all can do it!!!

ENF donations need a major push through this last week – we currently stand at 15th in the country with total donations of \$195,568 and a per capita of \$9.572. We ended last year in 14th place with \$262,178 in donations and a per capita of \$13.323 – we need about \$68,000 more donations to be close to where we were last year and ensure that our ENF returns are maintained and/or increased in years to come. Like all our endeavors, our ENF donation levels should continue to grow – we've done it in the past and can do it again!!

The \$5 increase in Grand Lodge Assessments this year and the fact that over the last three years, that increase totals \$15/member has caused financial stress within our membership, our Lodges, and the Order in general. In raw dollars, these three adjustments appear to be a substantial increase, but when examined closely, they equate to about a 1.4 cent increase per day or about a 4 cent a day increase over the three years. It is crucial that we consider these adjustments in a much broader context than just the immediate dollar impact they represent to every member.

The primary motivation behind these adjustments is our commitment to maintaining the group Liability Insurance, a critical component of almost every Lodge operation. The privilege of selling alcohol in our Lodges significantly contributes to our ability to attract, maintain, and even grow membership – probably the major operational entity that keeps our Lodges solvent and open to the membership. Losing this privilege would result in a significant decline in both membership and Lodges – an outcome we must avoid if our Order is to continue, let alone grow. The decision to spread these increases over three years was a deliberate effort to lessen the immediate impact on our membership.

Offering further perspective, let's compare the four-cent-a-day increase to the recent 3-year hikes in various essential commodities: Meats, poultry, fish, and eggs up 8% - Fruits and vegetables up 9.3% - Electricity up 14.1% - Unities (gas service) up 20% - Airfares up 42.9% - Rent of primary residence up 7.5%. Considering these and many other substantial increases in our cost of living, the 3-year adjustments to our assessments were a measured and responsible approach to solving a major financial issue within our Order, the Lodges, and membership. Your understanding and support during these times are invaluable. Thank you for your continued dedication to our Order, and if you have further questions or concerns, please feel free to reach out.

At this Spring Conference weekend, we are honored to host our Grand Exalted Ruler, Randy P. Shook, and his lovely wife, Wanda. I know they look forward to seeing and visiting each of you over the weekend. They are genuinely a "down to earth" couple you will enjoy visiting. Please join Jane and me in welcoming and greeting them personally and taking the time to explain to them how your Lodge and our Association are promoting his theme "WE ARE THE ELKS"!!!

Please plan on attending, participating in the Business Sessions and planned activities, meet Grand Exalted Ruler Shook and First Lady Wands, and take what you learn back to your Lodge and apply it – hopefully helping to make your Lodge a more involved and stronger Lodge for the 2024/2025 year!!!

# **MEMBERSHIP**

Greetings to all. Welcome to GER Randy Shook and First Lady Wanda. Here is a brief report on membership thus far this year.

We started this year with 20,222 members; we currently have 21,605. We still have 1,331 delinquents, down over 300 since my last report in late December. That would give us a gain of 52, as the numbers stand now. I am confident we can get more of our delinquent members back into the Lodges. We also have 387 candidates waiting. If we get them all in, we could again be well on the positive side for the year. We have one more month left in the Lodge year; let's get after this! Initiate, Initiate, Initiate!

In this week's membership update from Grand Lodge, Mr. Gathen reports that we are currently in 12th place nationally for growth. We can do better; if we get all our waiting candidates on board soon, we can crack the top 10!

Our Order added 78,382 new members last year, a new record for us. We have had positive growth for two years in a row; we are now going for three years in a row, which has not happened since 1977. Three in a row, let's go!

Grand Lodge has a goal for each State to add 10% of its starting number as new members. For MD, DE, & DC, that would mean adding 2,022 new members. For the year we have added 2,144 new members thus far, so we have exceeded that goal again.

There is no substitute for an active membership committee. As mentioned in the Grand Lodge "Plus Membership" program, we need our committee to be a "team." Lodge Secretaries, you can give "read" access to CLMS to your Lodge membership chairs, making it easier for them to stay current on who needs to be contacted. Membership committee folks should become familiar with the Membership and Marketing guides, which are part of the "members only" part of Elks.org.

Keep in mind the availability of group photos of your new initiates. Please take a picture of the group of new members and email it to Rick Gathen at

The West has been very busy pushing snow, having family events at the Lodges, and drinking hot chocolate and hot toddies. Christmas holiday and New Year's celebrations went off without a bang, and new goals and agendas were set for the Lodges for the upcoming year of 2024 in the West.

Frederick Lodge #684: In the past four months, we initiated 54, and 9 were affiliated or reinstated. They used a Gratitude Grant for veterans' activities, including a visit from the Martinsburg facility and Montevue assisted living facility for an afternoon of bingo and a crab feast. We gave them goody bags of personal care items.

Frederick also held holiday parties for the local Boys and Girls club and the school SUCCESS program. For the Boys and Girls club, we had a pizza party and partnered with the local Jack and Jill club chapter to provide gifts and goody bags to the elementary and middle school students.

The SUCCESS program is for developmentally disabled young adults. We supplied \$2,100 in grocery gift cards for them to use to work with students on budgeting and cooking skills. Both these events were funded by a Beacon grant.

Frostburg Elks Lodge #470 presented \$6,000 to the Frostburg Fire Department from a combination of two Elks National Foundation (ENF) Community Impact Grants (Beacon and Spotlight). Funds will be used to help offset the cost of purchasing a new ladder truck. Lodges and Individual Lodge members are asked to donate to the ENF and in turn, Lodges can apply for funding for Community Project Grants. Since 2020, Frostburg Lodge has received \$36,500 in funding to support local organizations.

Cameron and his dad talked about how their lives had changed since Halloween while out trick-or-treating; Cameron suddenly tired out and had to sit down. His mom noticed a rash on his back. Blood work showed he has Acute Lymphoblastic Leukemia.

The original rounds of chemo, which put 95% of children into remission, didn't work on him, so he went through a month of a more vigorous regimen. They learned in February that he is in complete remission but still requires treatment at the hospital in Morgantown for the next couple of months. His parents alternate nights sleeping in his hospital room while the other stays home with his 5-year-old brother.

One member wrote, "This was one of the better things I have been part of since joining the Elks."

In all, Hagerstown Elks has used \$6,000.00 in Grant Money to support these two worthwhile programs that help residents in need.

#### "WHAT'S NEXT?"

I wish everyone a Happy Spring and congratulations to all the new Officers for the upcoming Elk Year.

There are many things to consider as a new Officer of your Lodge. You should know your Lodge Bi-Laws, House Committee Rules, and State and Grand Lodge Bi-Laws. This will save you a lot of time and possible headaches in the future, so know the rules. You also need to plan for possibilities and probabilities. So "What's Next?" Well, I'll tell you.

I'm talking about ensuring your Lodge Safety Team or Person is on top of their game.

It's more than just doing a monthly checklist and signing off. We must be aware of potential issues around the Lodge. Such as trees dropping limbs, slight plumbing leaks, or even scorched outlets. All of these can turn into major problems. They usually happen at 3:30 am on a weekend morning when no one is around, thus turning it into a catastrophic situation. This is a reminder that our insurance deductibles are now at \$10,000.00.

So, if you have an accident or Lodge damage, you must pick and choose when to tap into that deductible.

Also, we need to go through the Lodge and make record of any new furniture, equipment, or property for your insurance coverage. I suggest scheduling an insurance adjuster to come out and ensure everything is accounted for. We don't need to pay for things we don't own anymore. The bottom line is that we need to stay on top of the insurance business so we don't get burned. Again, don't hesitate to call me if you have any questions, ideas, or accident reports.
